004 Chair Strobeck

Meeting called to order at 12:25 p.m. as a sub-Committee pending arrival of House members. Full Committee convened at 12:30 p.m. with the arrival of Representatives Devlin and Kruse.

WORK SESSION ON HB 2461 A-ENG.

007 Chair Strobeck

Described the effect of the (-A8) amendment, as follows:

- 1. Eliminates the sunset off the \$0.10 tobacco products tax.
- 2. Changes the tax on cigars to be no more than \$0.50 per cigar, with a sunset of January 1, 2002. (Exhibit 1)

011	Richard Yates	Noted that a wholesaler distributes cigars in various price ranges and described two possible interpretations of the (-A8) amendment, line 14, (Exhibit:
		 Is it the average over all cigars that are distributed that cannot exceed \$0.50, or Is it for any one type of cigar brand or package that would be purchased in a cigar store that the average tax couldn't exceed \$0.50?
		It was my understanding that the latter scenario was the intent, but the Department administering this program requested clarification.
		Distributed staff measure summaries, revenue and fiscal impacts from Senate and House Revenue Committees and Joint Ways and Means Committee. (Exhibit 2)
020	Chair Strobeck	The difference is whether they are boxed or single; is that the issue?
021	Yates	"It is not an average over a distribution which involves a lot of different quality and price range, but for any given cigar that is sold the price cannot exceed \$0.50."
023	Chair Strobeck	"That is a fair comment, ëit may not exceedí is the operable part of the amendment."
027	Sen. Derfler	The sunset on cigars would go away in two years?
030	Chair Strobeck	"It would revert back to the Measure 44 level of taxation unless the sunset is removed." Reviewed the discussion behind the language, testimony in the House Committee that there would be a change in purchasing habits, but there was no data to support that. "The House thought that if the sunset provision was in the measure then in the 2001 session data would be available to make an evaluation of what the consumption patterns have been and can be continued, if desired."
042	Sen. Derfler	I would oppose this.
044	Chair Miller	"I will oppose the sunset on the cigar tax. I believe that in 2001 there will be the opportunity to review any or all portions of this measure. It seems almost to conflict in theory as to why one sunset would be applied and another removed."
052	Chair Strobeck	"The idea was the \$0.10 cents on cigarettes was imposed prior to passage of Measure 44 and has been extended by several legislative sessions since then. However, tobacco is a change in the voter passed Measure 44 and again rather than making it a complete

change without knowing the ramifications are the sunset allows for gathering of data
and know the implications of making that change on the cigar portion of tobacco
products."

063	Chair Miller	"My experience has been that people supporting and opposing this change will provide all of the data necessary."
067	Rep. Kruse	Spoke to the sunset of the cigarette tax and the thought process employed, as sponsor of the bill, in removing the sunset on cigarettes in the original legislation.
082	Chair Strobeck	The disagreement is centering on whether there should be a sunset on the new change, which proposes a change in the way cigars are taxed.
086	Rep. Kruse	"Sen. Miller is correct in that any issue can be revisited, but having a sunset forces the revisitation. The opposition to imposing this change to the cigar tax might be softened by implementing the sunset for the purposes of conducting a study and obtaining valid data."
095	Sen. Derfler	Spoke to the advantages and disadvantages of a sunset.
103	Rep. Devlin	Spoke to a conversation with the former House Chair of Revenue, Commissioner Bryant about the sunset on cigarettes; his recommendation was that if it was not eliminated the review date be set further out into the future.
117	Chair Strobeck	Recessed until 12:38 p.m.
117	Chair Strobeck	Reconvened at 12:38 p.m.
117	Sen. Derfler	MOTION: MOVED BY CONCEPTUAL AMENDMENT ON LINE 13 PAGE 1 OF (-A8) AMENDMENT DELETION OF THE SUNSET LANGUAGE ON CIGARS BE ADOPTED.
119	Sen. Beyer	Would support the offered amendment in consideration of the timelines and the need to pass this bill today.
124	Richard Yates	Briefed Dexter Johnson, Legislative Counsel, on the motion before the Committee.

Removing the sunset on line 13 of the (-A8) amendment would effectively restore the	
language in the A-Eng. bill, correct?	

138	Sen. Beyer	Did the A-Eng. measure delete the sunset on the cigarette tax?
148	Yates	The Senate put a sunset into the bill; the House version did not have a sunset on the cigarette portion.
152	Chair Miller	As I understand it, if the (-A8) was adopted without ß5 the sunset on cigarette tax would be removed from the A-Eng. version of the measure.
167	Dexter Johnson	If you want to just remove the sunset on the cigarette tax you would want the (-A8) amendment, lines 1-3, (Exhibit 1).
171	Chair Strobeck	The proposal is to delete the sunset from the cigarette tax, but also to delete the sunset from the cigar portion.
173	Johnson	Then the (-A8) amendment, lines 1-3 would need to be adopted.
179	Yates	All that is needed is lines 2-3 of the (-A8) amendment, (Exhibit 1).
180	Johnson	Concurred.
181	Sen. Derfler	AMENDED MOTION: MOVED BY CONCEPTUAL AMENDMENT THAT LINES 2 AND 3 ON PAGE 1 OF THE (-A8) AMENDMENT BE ADOPTED.
188	Chair Strobeck	The motion will remove the sunset from both cigarettes and cigars in HB 2461 A-Eng.
