OPENS WORK SESSION ON HB 2208

007 MOTION: REP. JOSI: Moves HB 2208 to the floor with a DO PASS AS AMENDED RECOMMENDATION, AS AMENDED BY THE HB 2208-3

AMENDMENTS, LC 514, dated 2-15-93, by the Subcommittee on Agriculture and Forestry, and the bill will be referred

to the Committee on Ways and Means.

010 CHAIR BAUM: Restates motion and calls for discussion.

014 CATHERINE FITCH, Committee Administrator: Describes HB 2208, which repeals the "sunset" date for the animal health remedy regulation

program.

024 VOTE: In a roll call vote, REPS. HOSTICKA, JOSI, LUKE,

PETERSON, REPINE, VanLEEUWEN AND CHAIR BAUM vote AYE. REP. MARKHAM votes NO. REPS. DOMINY AND FISHER ARE ABSENT. REPS. DELL AND NORRIS are EXCUSED. REPS. DOMINY AND FISHER VOTE LATER DURING THE MEETING. 0.31 CHAIR BAUM: The motion CARRIES. No carrier is needed for this bill. 032 CLOSES WORK SESSION ON HB 2208. OPENS WORK SESSION ON HB 2212. 037 MOTION: REP. REPINE: Moves HB 2212 to the floor with a DO PASS AS AMENDED RECOMMENDATION, AS AMENDED BY THE HB 2212-3 AMENDMENTS, LC 519, DATED 2-15-93, by the Subcommittee on Agriculture and Forestry. FITCH: Describes HB 2212, which expands definition of "meat 042 animal." REP. MARKHAM: Are slaughterhouses regulated by state or 060 federal agencies? PHIL WARD, Department of Agriculture: For the past ten 062 years, inspections have been performed by a federal agency. A federal inspection would be required with this enhanced definition. REP. MARKHAM: But the state tells the federal agency what to 064 inspect? 066 WARD: Yes. 067 REP. MARKHAM: What if the slaughterhouse will not accept buffalo, since they are difficult to control when they become angry? Can they be forced to accept these animals? 074 WARD: This bill would not force a slaughterhouse to accept a certain type of animal. 079 CHAIR BAUM: If there is a demand for the product, slaughterhouses will accommodate them. 086 VOTE: In a roll call vote, all members present vote AYE. REPS. DELL AND NORRIS are EXCUSED. 090 CHAIR BAUM: The motion CARRIES. REP. FISHER will lead discussion on the floor. 096 CHAIR BAUM: Requests suspension of rules to allow Reps. Dominy and Fisher to cast their votes on HB 2208. 098 VOTE: REPS. DOMINY and FISHER vote AYE. 104 REP. LUKE: If we would have voted on the amendments to HB 2208, I

would vote no. If we had voted on the entire bill, I would vote aye.

113 KATHRYN VAN NATTA, Committee Administrator: Clarifies procedures for bill passage between subcommittees and the full committee. The HB

2208-3 amendments which were adopted as part of the motion today were a combination of the -1 and -2 amendments.

128 REP. HOSTICKA: I thought we were voting on the bill as amended by the subcommittee.

129 CHAIR BAUM: The amendments are consolidated, and we vote on the entire package as amended.
