# GOVERNOR CHARLES H. MARTIN ADMINISTRATION

## Record Descriptions

### Summary of Records

The records of Governor Martin consist of correspondence, extraditions, proclamations, budget, legal, and legislative records. These records date from 1934 to 1939.

The records of Martin's office are predominately the incoming and outgoing administrative correspondence while Governor. Topics include electrical power, highways, capitol building program, county relief committees, grazing policy and labor.

### Administrative correspondence, 1935-1939

Arrangement: alphabetical by subject

Series documents the communications and activities of Governor Martin's office. Series includes correspondence, reports, and telegrams, legal and legislative records.

Topics include electrical power, highways, capitol building program, county relief committees, grazing policy and labor.

### Extradition records, 1935-1939

Arrangement: by county

Series documents activities involved in the extradition of criminals, both to and from the State of Oregon. Records include action reports, request to issue an extradition, extradition requests to other states, court orders, affidavits and investigation reports requested by the Governor to aid in his extradition decisions.

### Proclamations, 1935-1939

Arrangement: no arrangement

Series documents announcements made by the governor on various activities or events. Contents include subject of proclamation, date, and governor signature.

Subjects and topics include forest protection by closing and opening use of designated areas, election of certain persons, declaring constitutional amendment voted on to be in full force and effect, declaring legislative bills voted on at general election to be in full force and effect, Will Rogers Day, and Armistice Day.
