Remember: you have to return your ballot so it's received in your county elections office by 8:00 pm on Tuesday, November 7th.

Our ability to vote in free, fair elections is one of the things that makes America great. Please take the time to read about the candidates in this pamphlet so that you can make informed choices. Then fill out your vote by mail ballot and return it to your county elections office by 8:00 pm on November 7th.

# Voters' Pamphlet

Your official 2006 General Election Voters' Pamphlet is divided into two separate volumes. This is Volume 2 and contains information on candidates. You should have already received Volume 1, containing information on the statewide measures. If you have not received Volume 1, please call the toll-free voter information line at 1-866-ORE-VOTES (1-866-673-8683).

In this volume, partisan candidates appear before nonpartisan candidates. All space is purchased; statements and photographs are submitted by the candidates or their designated agents. The information required by law—pertaining to occupation, occupational background, educational background, and prior governmental experience—has been certified by each candidate.

Volume 2 also includes other voting aids, such as a complete listing of state candidates, ballot drop site locations, and ballot instructions. If your county has chosen to produce a voters' pamphlet in conjunction with the state, drop site locations will appear in your county voters' pamphlet, which is in the center of this pamphlet.

#### Candidate statements are printed as submitted by the author. The state does not correct punctuation, grammar, syntax errors or inaccurate information. The only changes made are attempts to correct spelling errors if the word as originally submitted is not in the dictionary.

The voters' pamphlet has been compiled by the Secretary of State since 1903, when Oregon became one of the first states to provide for the printing and distribution of such a publication. One copy of the voters' pamphlet is mailed to every household in the state. Additional copies are available at the State Capitol, local post offices, courthouses and all county elections offices.

### **Random Alphabet**

While the candidates' statements for candidates running for the same office appear in alphabetical order by their last name in this voters' pamphlet, you will notice that they appear in a different order on your ballot.

ORS 254.155 requires the Secretary of State to complete a random order of the letters of the alphabet to determine the order in which the names of candidates appear on the ballot.

## Important!

If your ballot is lost, destroyed, damaged or you make a mistake in marking your ballot, you may call your county elections office and request a replacement ballot. One will be mailed to you as long as you request it by November 2. After that, you may pick it up at the elections office. If you have already mailed your original ballot before you realize you made a mistake, you have cast your vote and will not be eligible for a replacement ballot.

Your voted ballot must be returned to your county elections office by 8:00 p.m. election day, Tuesday, November 7, 2006.

#### Postmarks do not count!

County elections offices are open on election day from 7:00 a.m. to 8:00 p.m.

# **Voters with Disabilities**

Voters with disabilities who need assistance with marking their ballots now have an opportunity to vote privately and independently. Each county elections office in Oregon has been equipped with a voting system for use by voters with disabilities.

Voters with disabilities who use assistive technology such as a computer with a screen reader or screen enlarger application to access printed material now have an alternative to the printed ballot. It is called a HTML (Computer) Ballot. The HTML (Computer) Ballot requires that the voter have a computer, web browser and printer and allows the voter to vote privately and independently from home.

#### • FUND EDUCATION AND PUBLIC SAFETY FIRST

In Oregon's budget process, kids should not be at the end of the line. Time after time, the legislature passes agency budgets first. # LANE COUNTY CHARTER AMENDMENT TO LIMIT INCOME TAX

**QUESTION:** Shall County Charter limit income taxes, dedicate revenues to public safety, and provide property tax relief and a reserve?

SUMMARY: This Home Rule Charter Amendment:

· Limits County income tax authority.

• Requires voter approval for any rate higher than 2.0 % of net income.

• Applies to tax years starting January 1, 2007.

• Dedicates income taxes (after collection expense) to public safety only. Public safety is defined as programs to protect citizens from the effects of, or to reduce, criminal activity. Includes adult and youth corrections, crime prevention, detention, supervision, and patrol. Includes mental health and crime victim services, alcohol and drug treatment. Includes Sheriff, Youth Services and District Attorney departments, related support services.

 Through 2012, focuses increased funds on reducing illegal drug activity and family violence, enhancing treatment and prevention programs.

• Requires any income tax provide property tax relief to income taxpayers.

• Requires dedicated fund for income tax revenues and a reserve of 10% of annual income tax revenue.

The Commissioners have enacted an income tax ordinance within these limits on residents, nonresidents and businesses. It takes effect only if this measure passes.

## **Explanatory Statement**

Measure 20-114 amends the county charter and activates a county public safety income tax ordinance. Specifically, the measure:

1) Amends the County Charter to limit the Commissioner's existing authority to impose an income tax in the following ways:

Caps the rate of any County income tax at 2% of net income. Restricts use of a County income tax to funding Public Safety (see definition in ballot title).

Requires Public Safety to be budgeted separately from the rest of County government.

Establishes a reserve to stabilize Public Safety services during economic downturns and unforeseen events. Requires that any income tax include property tax relief

equivalent to \$.95 per thousand of assessed value. The above provisions can be changed only by a vote of the people.

2) Activates an income tax ordinance already passed by the Board of Commissioners. The provisions of this income tax are:

Rate is 1.4% on <u>net income</u> of businesses operating in Lane County. Businesses with gross income less than \$25,000 need not file.

Rate is 1.4% on resident's <u>county taxable income</u>. Persons with adjusted gross income less than \$20,000 (Joint) or \$10,000 (single) are exempt.

<u>County taxable income</u> is "Oregon taxable income" (see line 28 on Oregon Form 40 or line 12 on Form 40S) <u>minus</u> \$15,000 (Joint or Head of Household) or \$7,500 (Single or

#### Married Filing Separately

County taxable income excludes Social Security, State and federal pension income, standard or itemized deductions, and the Oregon deductions for federal tax.

Nonresident taxable income is the sum of County taxable income from wages earned in the county, plus net county asset income.

Real property owners, including businesses, will receive a tax credit equivalent to \$.95 per thousand of assessed value. Occupants of rental housing will receive a tax credit of \$30 per unit.

Non-residents and residents reporting no income in Lane County will receive no tax credit/property tax relief. Employers will withhold personal income tax. Estimated tax payments would be required of some filers.

Any county income tax paid by individuals will qualify as an itemized deduction on both state and federal returns.

3) Adds \$23.1 Million in county spending on Public Safety with an emphasis on combatting methamphetamine use and related crime - including funds to restore sheriff's deputies, staff and open existing adult jail and juvenile detention beds, hire prosecutors and juvenile officers, improve victim support, enhance crime prevention and expand drug treatment. The 2% tax rate cap in the Charter Amendment is higher than the 1.4% rate in the enacted ordinance. The difference (.6%) reflects additional revenue that would be needed if Congress reduces or eliminates federal timber payments to Lane County. If Measure 20-114 is not approved, the Commissioners will retain authority to impose an income tax without restrictions as to rate or purpose, but subject to possible referendum vote. # **General Information**

# Vote by Mail

#### What is Vote by Mail?

Vote by mail is a method of conducting elections. Instead of using traditional polling places where voters go to cast ballots on election day, a ballot is automatically mailed to each registered voter. The ballot is then voted and returned to the county elections official to be counted.

#### As a voter, what do I have to do?

Your ballot packet will automatically be mailed to you between October 20 and 24, 2006. Inside the packet you will find the ballot, a secrecy envelope and a return envelope. Once you vote the ballot, place it in the secrecy envelope and seal it in the pre-addressed return envelope. Be sure you sign the return envelope on the appropriate line. After that just return the ballot either by mail or at a designated dropsite.

#### What if I am uncomfortable voting my ballot at home?

Privacy booths are available for you to cast your ballot. There are privacy booths at your county elections office and there may be others at dropsite locations elsewhere in your county. For further information, call your county elections official.

#### What if my ballot doesn't come?

If you are registered to vote and have not received your ballot within a week after they are mailed, call your county elections office. They will check that your voter registration is current. If it is, they will mail you a replacement ballot.

# What if I have moved and have not updated my registration?

If you were registered to vote by October 17 but now have a different address, call your county elections office for instructions on how to update your registration and receive a ballot.

#### Do I have to return my ballot by mail?

You have the choice of mailing your ballot or returning it to any county elections office or any designated dropsite in the state. The times and locations of dropsites are available at your county elections office.

#### How much postage is required to mail the ballot back?

Your voted ballot can usually be returned using a single 39¢ stamp. In those instances where additional postage is necessary, it will be clearly indicated on the ballot materials.

#### When must the voted ballot be returned?

The voted ballot must be received in any county elections office or designated dropsite by 8pm on election night. **Postmarks do not count!** 

#### How do I know if my ballot is received?

You can call your county elections office and ask if they received your ballot. A record is kept showing each voter whose ballot has been returned.

# Can anyone find out how I've voted once I mail my ballot?

No. All ballots are separated from the return envelope before the ballots are inspected. This process ensures confidentiality.

#### What if I forget to sign the return envelope?

Generally, your elections office will either return it to you for signing or they will contact you, if possible, to come to the elections office to sign it. If the return envelope does not get signed before 8pm on November 7, the ballot will not be counted.

#### Can the public watch the election process?

All steps of the process are open to observation by the public. Contact your county elections official to make arrangements.

#### When will election results be known?

Ballot counting cannot begin until election day. Initial results are released at 8pm election night and will continue to be updated through election night until all ballots have been counted.

### Important!

If your ballot is lost, destroyed, damaged or you make a mistake in marking your ballot, you may call your county elections office and request a replacement ballot. One will be mailed to you as long as you request it by November 2. After that, you may pick it up at the elections office. If you have already mailed your original ballot before you realize you made a mistake, you have cast your vote and will not be eligible for a replacement ballot.

Your voted ballot must be returned to your county elections office by 8pm election day, Tuesday, November 7, 2006.

#### Postmarks do not count!

County elections offices are open on election day from 7am to 8pm.

### **Provisional Ballot Information**

You will be issued a provisional ballot if:

- → there is a question about your eligibility as a voter (for example, there is no evidence on file that you are an active or inactive voter in Oregon)
- → you need to vote at a County Elections Office in a county other than the one you live in

In order to obtain a provisional ballot, you need to fill out a Provisional Ballot Request Form in person at the County Elections Office.

Your provisional ballot will not be counted until it is determined that you are eligible to vote.

After you have voted the ballot, you can call 1-866-ORE-VOTES (1-866-673-8683) or the County Elections Office in which you voted to find out if your ballot was counted. If your ballot was not counted, you can also find out the reason it was not counted.

If it is determined that you are ineligible to vote in this election, the completed Provisional Ballot Request Form will serve as your voter registration for future elections.
