- 1. That my true name is Frank Halley.
- 2. That my age is 42 years.
- 3. That my residence is Willamette, State of Oregon, County of Clackamas.
- 4. That my occupation is farmer.
- 5. That my postoffice address is Willamette, Oregon.
- 6. That said worm and still are to be kept on that property belonging to James and Lucy Kaiser, more particularly described as follows; to-wit:- 13.84 acres more or less, situated in the J. M. Moore D.L.C. and lying in Sections 27, 28, 35 and 34, T. 2 S. R. 1 E. of the W. M. Clackamas County State of Oregon.
- 7. That said worm and still aremade (sic) of Galvanized Iron; that said still stands approximately 6 feet in highth (sic) and is approximately 18 feet in circumference; that the capacity for peppermint hay of said still is approximately 1500 lbs.
- 8. That said still and worm are to be used for the purpose of extracting oil from peppermint hay.
- 9. That said still and worm are not intended nor will they be used in the unlawful manufacture of intoxicating liquor.
