

Vote Proclamation to Repeal Prohibition

Proclamation by Governor Julius Meier declaring the passage of the constitutional amendment repealing state prohibition in Oregon, Secretary of State Official Documents, 2 pages, December 9, 1932. (Original document on page 3)

PROCLAMATION

WHEREAS, A Law (to repeal Chapter I, Title 15, of Oregon Code 1930--) (<u>which law</u>) was proposed by Initiative Petition filed in the office of the Secretary of State of the State of Oregon, February 11, 1932 and was submitted to the legal electors of the State of Oregon at the Regular General Election held within and for said State on Tuesday the eighth day of November, 1952, as provided by the Constitution and Laws of the State of Oregon, and designated on the official ballots for said Regular General Election under the following ballot title and ballot numbers:

INITIATIVE BILL – PROPOSED BY INITIATIVE PETITION

BILL TO REPEAL STATE PROHIBITION LAW OF OREGON—Purpose: to repeal the general prohibition law of the state of Oregon, which prohibits the manufacture, sale, giving away, barter, delivery, receipt, possession, importation or transportation of intoxicating liquor within this state, and provides for the enforcement of such prohibition; and thus to do away with prohibition and its enforcement in and by the state of Oregon.

AND WHEREAS, On the ninth day of December, 1932, the Secretary of State, pursuant to the Constitution and Laws of the State of Oregon, in my presence as Governor of the State of Oregon, did canvass the votes cast for and against said Law;

AND WHEREAS, It was ascertained and determined upon such canvass that there were 206,619 votes cast for said Law, and 138,775 votes cast against the same, and that said Law received an affirmative majority of the total number of votes cast thereon and entitled to be counted under the provisions of the Constitution and Laws of the State of Oregon.

NOW, THEREFORE, I, JULIUS L. MEIER, Governor of the State of Oregon, in obedience to and by virtue of the power and authority vested in me by the Constitution and Laws of the State of Oregon, do hereby make and issue this proclamation to the people of the State of Oregon and do announce and declare that the whole number of votes cast in the State of Oregon at said Regular General Election of November 8, 1932, for and against said Law was as is hereinbefore stated, and that said Law submitted to the people under the said ballot title and ballot numbers, towit:
