### Shooting with Your ObscuraFlex™ Adapter

Once your adapter is installed you can begin shooting stills and video immediately. Here are a few tips to help you get the best results.

#### A WORD ABOUT APPS:

- CONTROL Most phones use software to deliver the "best" image.
   When shooting with the adapter it is better to use a manual camera app like ObscuraFlex<sup>TM</sup> Flip or other pro photo app.
   If you use the phone's built in camera app, disable features like flash, macro, etc. Only the primary lens should be used.
- FOCUS Since your phone will only need to focus once, on the ObscuraFlex<sup>TM</sup> Focusing Screen inside the adapter, use AF-lock or our Flip app's manual focus tools to disable auto-focus.
- INVERSION An upside-down image is normal with any simple lens system. We created ObscuraFlex<sup>TM</sup> Flip to address this and the other needs mentioned above – see front page for details.
- FRAMING: The alignment of the focal plane is subject to many factors, the hardware on your vintage camera, your phone's hardware, even its image stabilization settings. To allow for these small variations the adapter displays an un-cropped image with a black border. This is normal. Crop your final images as needed.

\* Small adjustments to image alignment can be made by adding paper shims between the phone cradle and the adapter body.

- EXPOSURE: Like film photography, ample light is required to produce the best images. Your vintage camera lenses should be set wide open. The phone's shutter speed should be set for your desired exposure, with lower ISO settings resulting in cleaner images. Depending on your phone, good results may be possible with higher ISO settings and/or longer exposure times. The adapter is not ideal for low light photography but it may be possible using slow-shutter apps or the iPhone "Magnifier" app.
- FLASH: Electronic flash sync may be possible with third party hardware and software. Your phone's built in flash is not compatible and must be turned off.
- VIDEO: Most smartphones use a zoomed image for video capture, this will result in a slightly cropped final frame. Slow-motion video requires a lot more light and is best suited to shooting in full sun.


#### ObscuraFlex<sup>™</sup> Focusing Screen Installation

The "secret sauce" at the heart of the ObscuraFlex™ Adapter system.


HANDLING: Like traditional groundglass, ObscuraFlex™ focusing screens are delicate and highly susceptible to fingerprints, dust, and scratches. Handle with extreme care. All camera equipment can be damaged if exposed to high temperatures, avoid leaving your adapter in direct sunlight or in a hot vehicle.


**INSTALLATION:** ObscuraFlex<sup>™</sup> 4x5 screens are semi-rigid and made to match the standard 4x5 Graflex glass size: 4.8 x 3.9in (122 x 100mm). The screen will be held in place with the existing retaining clips of your Crown Graphic or Speed Graphic groundglass back.

ObscuraFlex™ screens are only intended for use with our adapters, not as a replacement for traditional photographic groundglass screens.



- Remove the pop-up sunshade from the back of your Graflex to gain access to the groundglass spring retaining clips.
- Use a small flat screwdriver to remove the retaining clips at each side of the groundglass. Carefully remove the glass and store in a safe place with the sunshade.
- · Carefully lay the focusing screen in place, matte side down.









#### ObscuraFlex™ Twist-lock Phone Cradle Installation

Depending on your model of phone, the alignment of the cradle may vary and it may or may not include a lens.



- Insert the "key" into the "lock" at an angle.
- Rotate the cradle clockwise until it's parallel to the adapter body and the retaining screw holes alian.
- If needed, add paper shims beneath the cradle to adjust image alignment.
- Use the included screw to secure the cradle.






MAKE SURE the retaining screw is tightened all the way so the head doesn't protrude - failure to do so could damage your phone.

## ObscuraFlex™ Adapter Installation

The main body of the adapter is designed to lock into the groundglass retaining clips that held the sunshade in place.



The light-tight foam strips should form a snug and secure fit. If the fit is not tight, adjustments to your camera, or thicker foam strips may be needed.

Avoid putting stress on the adapter once fitted.

Do not grip the adapter, or your phone, to move, aim, or lift the camera.
