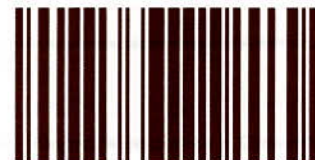

From Sea to Standing Trees

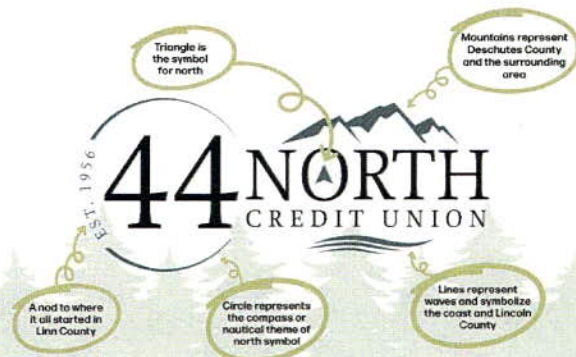
