

Fiscal Year 2023 Oregon Municipal Corporations: Summary of Financial Reporting

February 2025 Report 2025-08

## Background

Oregon's municipal corporations, as defined by Municipal Audit Law, include all counties, cities, school districts, special districts, and public corporations subject to control by local governments. Municipal Audit Law provides instructions for annual reports that municipal corporations are required to submit to the Secretary of State.<sup>1</sup>

Municipal Audit Law requires the Secretary of State, in cooperation with the Oregon Board of Accountancy and in consultation with the Oregon Society of Certified Public Accountants, to prescribe the minimum standards for the conduct of each audit. The Secretary of State requires independent accountants to follow professional auditing standards set by the American Institute of Certified Public Accountants (AICPA) and issue financial reports in accordance with generally accepted accounting principles.

About 1,800 municipal corporations are registered with the Secretary of State; all are subject to annual reporting requirements, but not all are subject to an audit. The type of reporting required depends on the municipality and its expenditures. All counties, school districts, and public charter schools, as well as municipalities with total annual expenditures of more than \$500,000, are required to have their financial statements audited each year.<sup>2</sup> Most municipalities operate on a July 1 to June 30 fiscal year. Audits are performed by local Certified Public Accountant firms and reports are to be filed with the Secretary of State by December 31 — six months after the end of the municipality's fiscal year.

Municipalities with total annual expenditures between \$150,000 and \$500,000 are not required to have an audit and may opt to have a financial statement review performed by an independent accountant. Municipalities with total annual expenditures of \$150,000 or less may submit reports in lieu of audit where they self-report expenditures on forms prescribed by the Secretary of State.<sup>3</sup> Financial reports filed with the Secretary of State are posted on the Secretary of State's website.<sup>4</sup>

## Fiscal Year 2023

Of the 1,840 municipal corporations in Oregon, 1,197 were expected to file audit reports with the Secretary of State for fiscal year 2023. However, 106 (9%) of those audits are more than a year late in their filing and were still not filed as of December 31, 2024; of those, four filed the wrong report. The number of non-filers has continued increasing since 2017 when only 19 entities remained delinquent after one year.

Municipalities and firms are still experiencing the lingering effects of the COVID-19 pandemic — specifically, decreased staffing from the "Great Resignation."<sup>5</sup> Despite recruitment efforts, staffing remained one of the most commonly cited reasons for filing late audit reports. Audit firm mergers, retirements, and some firms exiting the government auditing space have also contributed to the highest number of late filings, including municipalities not being able to engage a firm timely. For many municipalities, COVID-19 resulted in delinquencies from which they have yet to catch up.

#### Delinquent filers have increased dramatically

Fiscal year 2023 saw the highest number of non-filers since 2017, when this audit summary report was first published. At that time, only 19 entities remained delinquent after one year. For fiscal year 2023, that number was 106.

### **Report Filing Extensions**

Municipal Audit Law permits a municipality to request additional time to file its annual audit report for good cause or due to extraordinary circumstances. The request must be in writing and submitted to the Secretary of State Audits Division. It must include the cause for the delay and the expected report delivery date. Both the government official and the independent accountant make the request.

There were fewer requests for extension in fiscal year 2023 compared to the prior three years, although still higher than the number received prior to the COVID-19 pandemic. We received requests from 308 municipal corporations, one of every four filers. This represents a significant increase since 2015 when one in seven filers, or 15%, requested an extension.

The reasons cited for extensions vary. Reasons may include delays from unexpected vacancies of key staff at both entities and firms, implementation of new pronouncements from the Governmental Accounting Standards Board, changes to federal reporting requirements and increases in funding, and switching auditor or firm. Some requests were made as entities filed reports late for fiscal year 2022 and were unable to catch up and file their 2023 report by the deadline.

Requests for extension are typically not approved when a request does not demonstrate good cause as required, when the request is related to a report in lieu of audit, or when a municipality has routinely filed late reports.

The percentage of extension requests approved for the 2023 filing year was 82% and is on par with the average of the prior five years.

## Audit Deficiencies and Plans of Action

Most local governments receive a "clean" audit report each year without any qualifications or deficiencies noted. However, when deficiencies are reported, the governing body of a municipal corporation is required to determine the corrective measures it considers necessary to address the deficiencies. Municipal Audit Law requires a municipal corporation to file with the Secretary of State a copy of its plan of action within 30 days after filing its annual report. The plan must include appropriate actions to address the deficiencies noted and an estimate of the timeframe necessary to complete the planned actions.

### Statutory Requirements — Annual Summary Reporting

Oregon law requires the Secretary of State to prepare an annual summary report, which is to include the following:

- A list of municipal corporations required to file audit reports with the Secretary;
- A list of municipal corporations that filed audit reports with the Secretary within six months after the close of the year under audit;
- A list of municipal corporations that did not request a filing extension and did not file their report within six months of close of fiscal year;
- A list of municipal corporations that requested and were granted filing extensions and if they met their filing extension deadline;
- A list of number and type of deficiencies cited in audit reports; and
- A description of whether the municipal corporation submitted a plan of action to the Secretary of State.

This report and appendices fulfill the requirements outlined in the law.

# Summary Report

The requirements in Municipal Audit Law are intended for municipal corporations to be financially accountable to the public. There are many stakeholders involved in the municipal audit process. Government officials understand the annual reporting requirements; independent accountants provide timely audit services; the Secretary of State works as a resource for government officials and the audit community throughout the year to aid in understanding and ensure compliance; and the people of Oregon are informed of their local government's financial activities.

Oregon's Municipal Audit Law requires the Secretary of State to provide summary information on the status of audit report filings. This report summarizes the financial reporting activities of municipal corporations that submitted an audit report to the Secretary of State for the fiscal year ended June 30, 2023.

### Audit Report Filings

Of the 1,840 municipal corporations actively registered in Oregon, 1,197 were expected to file an audit with the Secretary of State. As shown in Figure 2, 66% of these municipalities filed their audit reports on time or within their approved extension deadline. Of the 253 that requested and received extensions, 118 filed their report within the extended deadline. As of December 31, 2024, 106 municipalities had not filed a fiscal year 2023 audit report; these municipalities included two counties, 39 cities, three school districts and education service districts (ESDs), five charter schools, 15 fire districts, and 42 special districts.





## Audit Report Deficiencies

Professional auditing standards require independent accountants to communicate, in writing, instances of significant deficiencies and material weaknesses to the municipal corporation's governing body and, by rule, provide a copy of the communication to the Secretary of State. A material weakness is a deficiency

severe enough that there is a reasonable possibility a material misstatement could occur and not be prevented, or detected and corrected, on a timely basis. A significant deficiency is less severe than a material weakness, yet important enough to merit the attention of the governing body.

Reported deficiencies generally fall into three broad categories: weaknesses in internal controls related to financial reporting; errors and misstatements in the financial statements; and violations of laws, rules, and regulations. As shown in Figure 3, of the 1,091 municipal audit reports filed for fiscal year 2023, 334 (31%) reported one or more audit deficiencies. A total of 639 deficiencies were reported overall, with the majority related to weaknesses in internal control. Of the municipalities with deficiencies reported, 82% filed a plan of action and 93% filed deficiency communications with the Secretary of State as required. The rate of compliance for filing the required plan of action increased this year from the prior high of 79% received in 2019.

#### **Internal Control Deficiencies**

At least one significant deficiency or material weakness in internal controls was reported for 334 municipalities. A deficiency exists when the design or operation of controls does not allow management or employees, in the normal course of performing their assigned accounting and financial reporting functions, to prevent, or detect and correct, financial misstatements on a timely basis. Inadequate segregation of duties and the inability to prepare financial statements are common in smaller governments with limited staff and remain the most prevalent deficiencies reported.

#### Accounting Errors and Misstatements

Auditors reported one or more significant deficiencies or material weaknesses related to accounting errors and misstatements for 128 municipal corporations. Errors and misstatements occurred in several accounts and funds. Many could have been detected and corrected timely if the municipal corporation had a stronger system of internal control. Some common errors are recording amounts in the wrong account or fund; recording purchases of capital assets as expenditures in the year of purchase instead of capitalizing and depreciating over their life expectancy; reporting items at insurance value or fair market value instead of historical cost; not reporting transactions at all due to lack of records; or incorrectly depreciating assets. There are also misstatements for the failure to recognize and record accruals required for revenues and expenditures. Inaccurate reporting makes financial statements less effective for decision making.

#### Compliance with Laws, Rules, and Regulations

Auditors reported one or more instances of significant noncompliance with laws, rules, regulations, or grantor requirements for 48 municipal corporations. Ad valorem taxes, such as property taxes, are a major source of revenue for most of Oregon's municipal corporations. As such, municipal corporations are required to prepare, adopt, and execute annual or biennial budgets in accordance with Oregon's Local Budget Law. Significant noncompliance with those requirements may result in deficiencies reported by the auditor. Other instances of noncompliance may pertain to Oregon's Public Contracting Code, failure to obtain required fidelity bond insurance coverage, or failing to comply with federal or state grant requirements.

### Conclusion

This summary report fulfills the legislative requirements of Oregon's Municipal Audit Law and presents a summary of financial reporting activity as of December 31, 2024. We appreciate the ongoing partnership with independent accountants and Oregon municipal corporations in ensuring compliance with the law and enhanced transparency.

We have included the summary information required by law in the following appendices:

**Appendix A** is a list of municipalities that filed timely reports within the six-month statutory deadline or within an approved extension deadline.

Appendix B is a list of municipal corporations that either filed reports beyond an approved extension of time or filed late and did not file a request for an extension.

Both Appendix A and Appendix B identify whether letters reporting material weaknesses or significant deficiencies issued by the independent accountants were received and whether a plan of action adopted by the governing body was filed. Both items are required to be filed with the Secretary of State when significant or material deficiencies are reported.

Appendices A and B also include the number and type of material weaknesses and significant deficiencies reported by the independent accountants and filed with the Secretary of State.

Appendix C is a table showing the municipal corporations that had not filed as of December 31, 2024.
