(5) DESCRIPTION OF TRADE OR SERVICE MARK (Continued):

This is the variation of the official logo of the Oregonians Financial Planning division of Oregonians Credit Union, including the tagline. The instructions state to include all designs that comprise the mark. We perceived this to include color variations. The black and white version of the mark is provided above. This mark will be used in different colors, to include the versions of the mark provided below:

(Section 10 & 11) First date of use: 11/26/2024

(Section 5) Mark Description – this mark is comprised of:

- 1. The outline of the state shape of Oregon.
 - a. Inside the state shape are the letters "OR", capitalized and bold.
- 2. Continuing with the letters "OR" inside the state shape, are the letters "EGONIANS" outside the state shape, intentionally to spell the word "OREGONIANS".
 - a. The letters "EGONIANS" are slightly smaller than the letters "OR".
- 3. Underneath the letters "GONIANS" are the letters "FINANCIAL PLANNING" in a smaller font size than the letters "OREGONIANS".
- 4. Underneath the state shape outline, the word "OREGONIANS", and the words "FINANCIAL PLANNING", is a row of text that has three words "RETIREMENT", "INVESTMENTS" and "INSURANCE", which each word separated by a | (vertical line) symbol.
 - a. This row of text is slightly smaller than the words "FINANCIAL PLANNING".
- 5. In two-tone color versions of this mark, the state shape, the letters "EGONIANS", "FINANCIAL PLANNING" and "RETIREMENT | INVESTMENTS | INSURANCE" are the same color; and the letters "OR" inside the state mark are a second color.
- 6. Overall, the mark has a rectangular shape.
