- a.) Any agreement by Lender to release a titled vehicle held as Collateral shall be subject to Lender's approval in its sole discretion.
- b.) All applications for certificates of title, together with any other vehicle paperwork submitted to the Department of Motor Vehicles to obtain a certificate of title for any titled vehicles purchased hereafter with loan proceeds, shall: (i) include Lender as the lienholder; and (ii) reflect Grantor as defined in the Agreement as the owner of any such vehicles.
- c.) In the event Grantor receives certificates of title subject to the Agreement or this Exhibit, Grantor shall deliver such titles to Lender within ten (10) calendar days of receipt. Grantor agrees to execute any additional security instruments or other documents as Lender may require from time to time, and pay all fees and expenses required to perfect Lender's security interest in any titled vehicles.

ELECTRONIC EXECUTION AND DELIVERY: The authorized signer(s) on behalf of Borrower and Grantor may execute and deliver this Titled Vehicle Exhibit electronically, such as a facsimile or pdf submission. Such submission of this document shall be considered the same as delivery of an original document; however, Lender may request an original document at any time.
