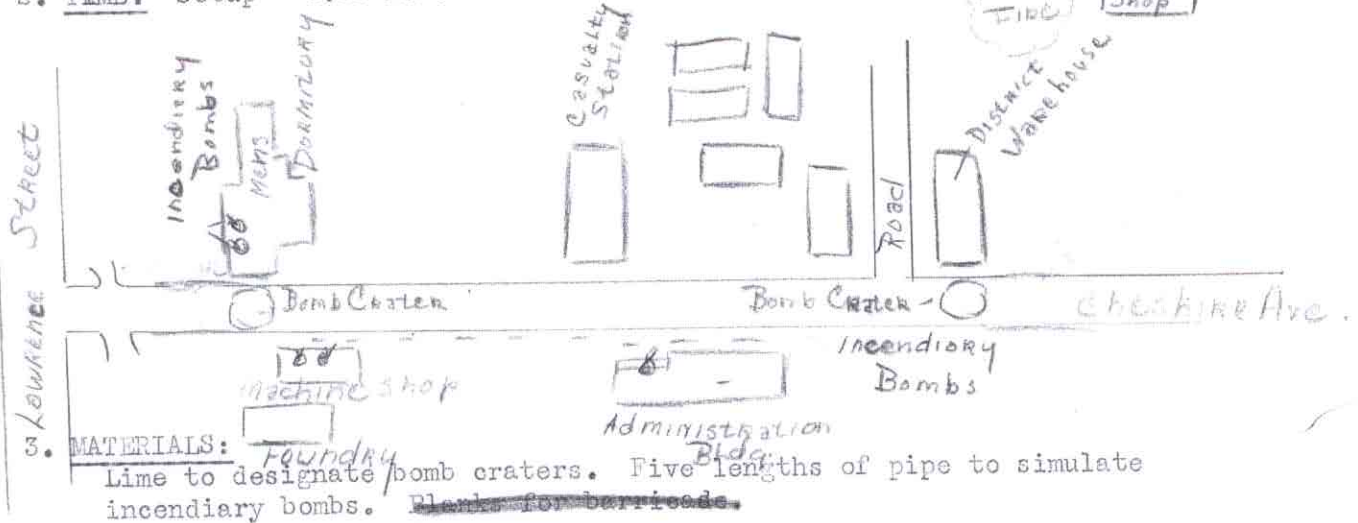


INCIDENT IN DISTRICT A

1. PLACE: NYA settlement on Cheshire Avenue.

2. TIME: Setup - ^{6:20}~~6:05~~ P.M.

Incident - ^{6:31}~~6:15~~ P.M.



4. PERSONNEL: One truck driver; fifteen persons to act as casualties, killed and injured.

5. DESCRIPTION OF INCIDENT: Truck driver with above materials will leave 101 West 5th Street in time to complete the setup of the incident by ^{6:20}~~6:05~~ P.M. The rest of the personnel will meet him in front of the administration building.

Truck with materials will proceed to place as indicated on map above; two bomb craters are to be indicated by circles of lime fifteen feet in diameter--one on Cheshire Avenue in front of the men's dormitory and one on Cheshire Avenue in front of the District Warehouse.

Paint-shop fire to be started at ^{6:25}~~6:10~~ P.M.

Casualties are to be indicated by placards and to be distributed as follows: two are to be buried in wreckage of the foundry, one with a concussion and a crushed chest, and the other suffering from head wound over right eye, badly crushed right foot, and broken left leg. Thirteen casualties suffering from bullet wounds lie on the ground between the men's dormitory and the casualty station; they are injured as follows: three dead, one with chest wound, one with head wound over the left eye, one with bullet wound through right shoulder, one with bullet wound through abdomen, one with right arm shattered above the elbow, one with wound in left leg above knee, one with neck wound and severe bleeding from artery, one with bullet wound in left hand, one with injured spine.

Pipes or sticks simulating incendiaries should be placed as follows: One phosphorus bomb on the porch of the administration building, two magnesium bombs in the machine shop and two magnesium bombs in the Men's dormitory. (Yellow paint used to color phosphorus bomb; white for magnesium)

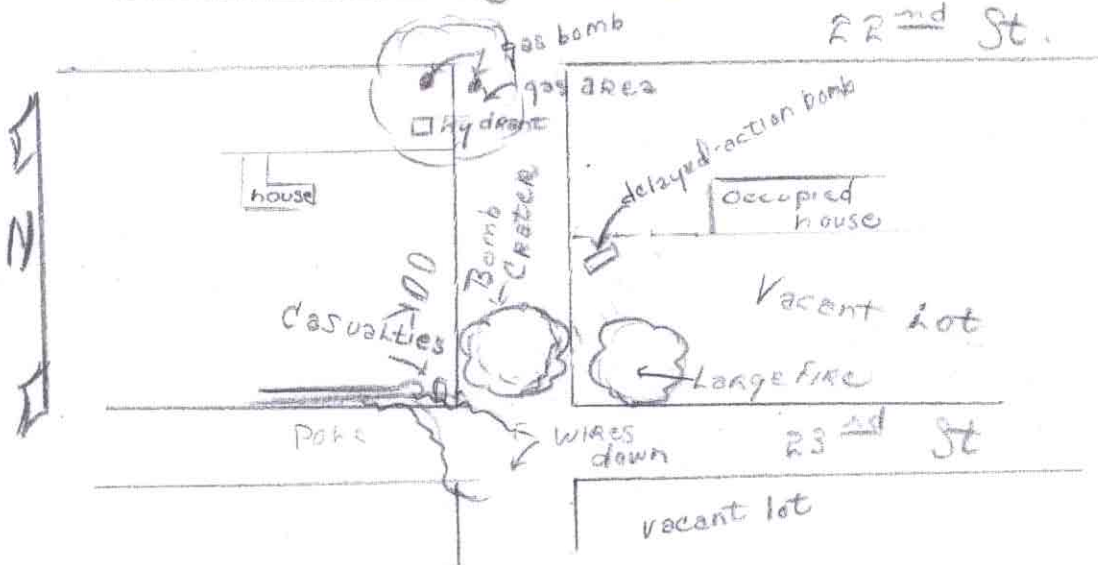
6. TIME INCIDENT CLOSED: ^{7:15}~~7:00~~ P.M.

INCIDENT IN DISTRICT B

1. PLACE: Charnelton Street between 22nd and 23rd.

2. TIME: Setup - 7:20 P.M.

Incident - 7:31 P.M.



3. MATERIALS: One truck loaded with materials for large fire; ~~plants and horses~~ for ~~barricaded street~~; lime to designate bomb craters; wires or ropes to indicate hot wires; large crate or barrel to simulate delayed-action bomb; smoke bombs to simulate gas.
4. PERSONNEL: One truck driver; three persons to act as killed and injured, such persons to assist in setting up the incident.
5. DESCRIPTION OF INCIDENT: Truck driver with the above materials and personnel will leave 101 West 5th Street in time to complete the setup of the incident by 7:20 P.M.

Truck with equipment will proceed to place as indicated on map above; dump material for fire on vacant lot of NE corner of Charnelton and 23rd. "spread" lime in 15-foot circle on Charnelton just north of 23rd; string wires or ropes from pole on Northwest Corner of Charnelton and 23rd, to simulate "hot" wires. Place crate or barrel to simulate delayed-action bomb in vacant lot at extreme north end of lot near house. Place smoke bomb to simulate gas near fire hydrant on Charnelton and 22nd Street.

Fire to be started at 7:25 P.M.

The injured are to be disposed as follows: one lying on sidewalk on Charnelton and 23rd unconscious with hot wire in contact with body; one with a compound fracture of the right leg below the knee; one with head wound and chest wound.

6. TIME INCIDENT CLOSED: 8:00 P.M.

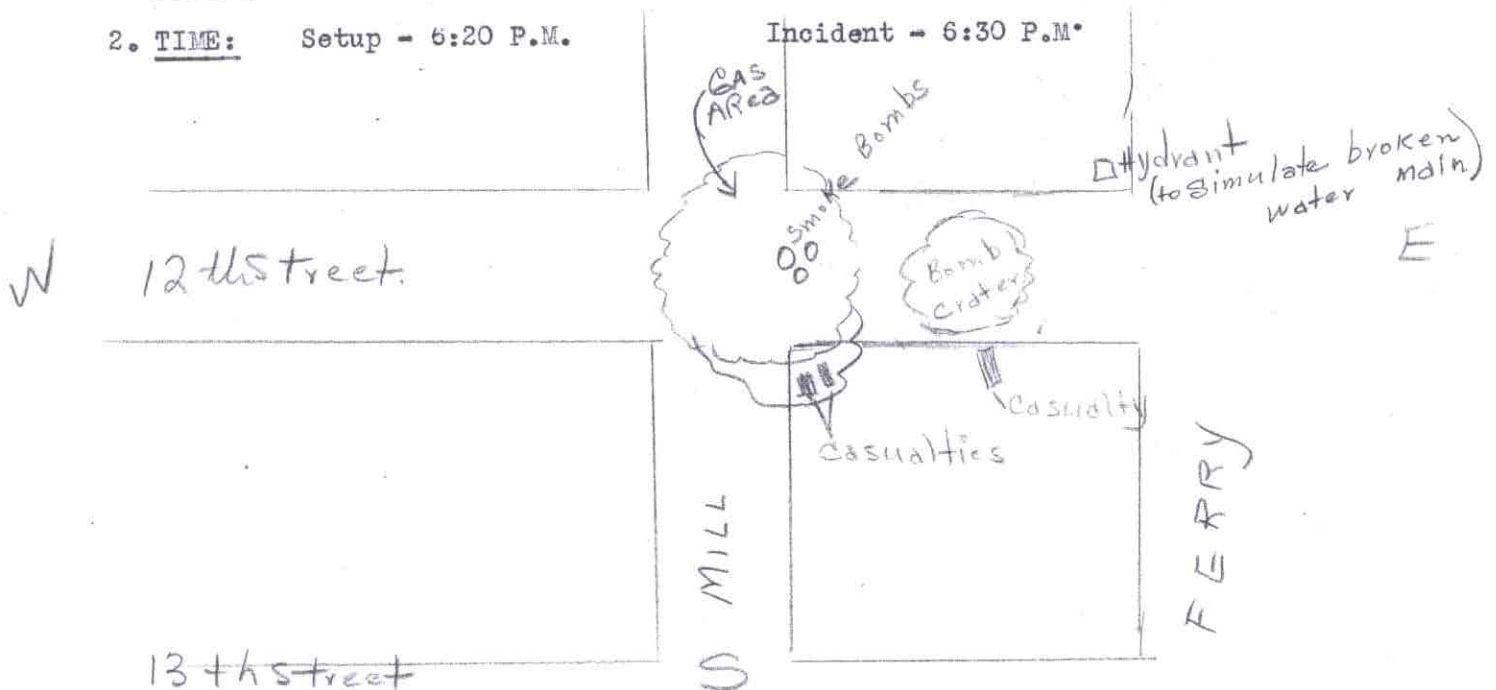

INCIDENT IN DISTRICT C

1. PLACE: 12th Street between Mill and Ferry.

2. TIME: Setup - 6:20 P.M.

Incident - 6:30 P.M.



3. MATERIALS: ~~One truck loaded with planks and horses for barricaded streets;~~
lime to indicate bomb crater; wrench to open water main; smoke bombs to indicate gas.
4. PERSONNEL: One truck driver; three persons to act as killed or injured; such persons to assist in setting up incident.
5. DESCRIPTION OF INCIDENT: Truck driver with the above materials and personnel will leave 101 West 5th Street in time to complete the setup by 6:20 P.M.

Spread lime to indicate bomb crater in 15-foot circle on 12th Street between Mill and Ferry. ~~12th Street to be barricaded at Mill and at Ferry.~~ Water main at corner of 12th and Ferry to be opened. Smoke bombs to be placed inside barricade at 12th & Mill.

The injured are to be disposed as follows: One person on parking opposite bomb crater, left foot blown off, brain concussion; Two gas casualties lying on sidewalk near barricade at 12th & Mill, suffering severe burns on face and hands from mustard gas.

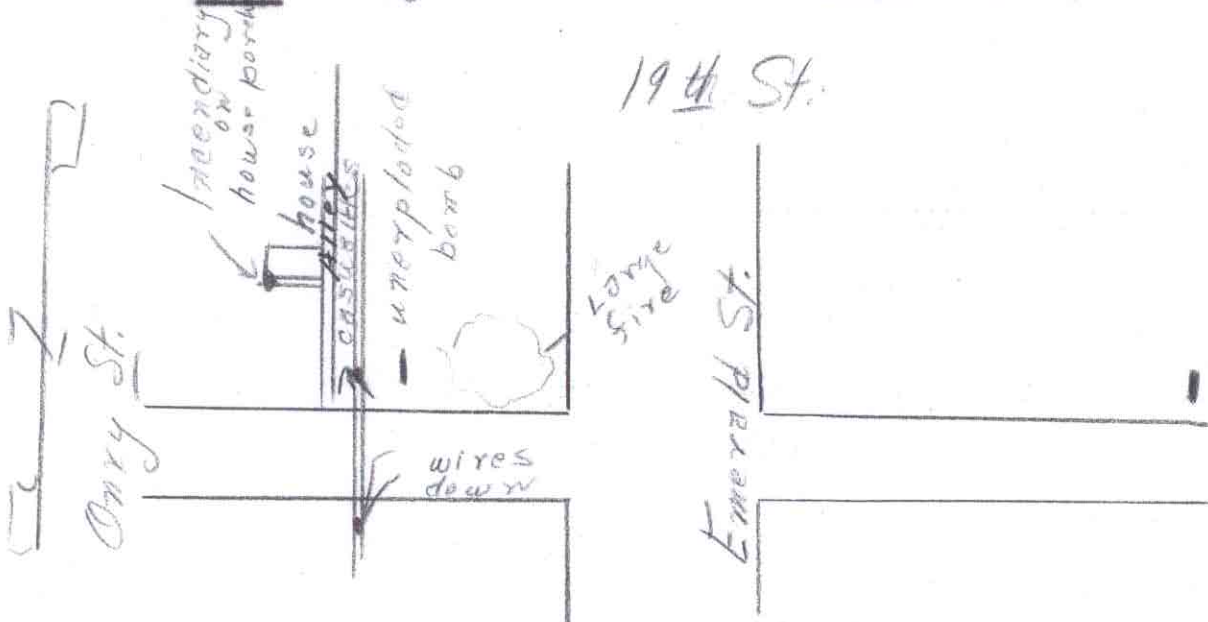
6. TIME INCIDENT CLOSED: 7:00 P.M.

INCIDENT IN DISTRICT D

1. PLACE: 20th Street between Onyx and Emerald.

2. TIME: Setup - 6:20 P.M.

Incident - 6:30 P.M.



3. MATERIALS: One truck loaded with materials for large fire; ~~plaster and houses for barricaded streets~~; 50 to 60 feet of wire or rope to be strung from telephone poles to simulate "hot" wires; large crate or barrel to simulate unexploded bomb; two sticks or pieces of pipe painted white, to indicate magnesium incendiaries.

4. PERSONNEL: One truck driver; three persons to act as injured individuals; such persons to assist in setting up incident.

5. DESCRIPTION OF INCIDENT: Truck drivers with the above materials and personnel will leave 101 West 5th Street in time to complete the setup of the incident by 6:20 P.M.

Truck driver with materials will proceed to place as indicated on map above; dump materials for fire on vacant lot at northwest corner of 20th and Emerald; place crate or barrel simulating unexploded bomb about 30 feet away from the fire, and near one of the three casualties; string wires across street from poles in center of block; place incendiaries on porches where householders permit.

Fire to be started at 6:25 P.M.

A fragmentation bomb has exploded in the vacant lot near the alley; three injured persons are lying near the spot. One person is bleeding severely from a neck wound; one has been wounded in the back of the head; one has a shattered knee.

6. TIME INCIDENT CLOSED: 7:00 P.M.

#2 INCIDENT IN DISTRICT A

1. PLACE: Eighth Street West and Olive.

2. TIME: Setup - 7:20 P.M.

Incident - 7:30 P.M.

3. MATERIALS: ~~One truck loaded with planks and horses for four barricades to simulate rubble from bomb crater;~~ lime to indicate bomb crater; wires to indicate "hot" wires; wrecked car; materials to simulate broken glass and rubble of destroyed buildings.

4. PERSONNEL: One truck driver; three persons to act as casualties; ten or fifteen persons to simulate crowd from theater; five persons to act as looters,

5. DESCRIPTION OF INCIDENT:

Truck driver with the above materials and personnel will leave 101 West 5th street in time to complete the setup of the Incident by 7:20 P.M.

Truck with materials and personnel will proceed to place indicated on map; spread lime in circle large enough to enclose entire street intersection; string wires along sidewalk along 8th Street side of Rubenstein Furniture Store. to simulate "hot" wires; place barriers to indicate bomb rubble; deposit materials on sidewalk east and south of Rubenstein Store to indicate broken glass; deposit materials on sidewalk south and west of building on northeast corner to indicate demolition of that building; deposit materials along north and west sides of building on southeast corner to simulate partial demolition and collapsing walls of that building; station personnel in front of the State Theater as indicated on map; also station looters at Rubenstein Store; place wrecked car as indicated.

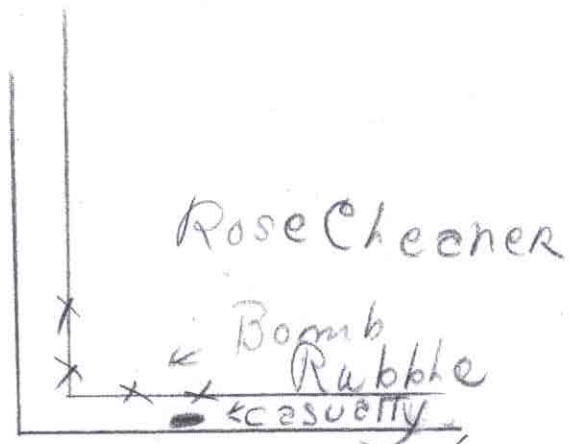
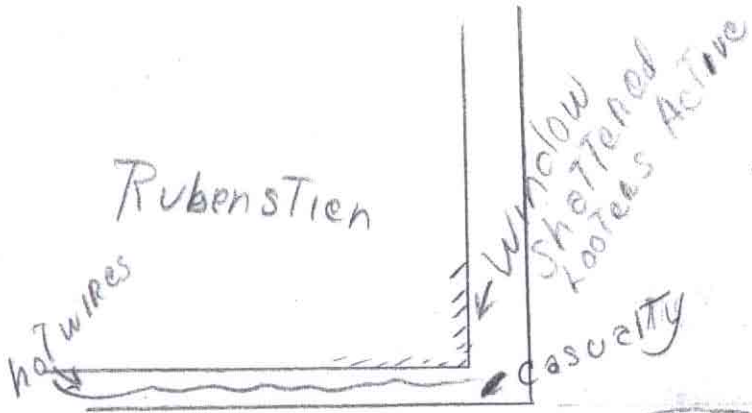
The Car should be fired at 7:29 P.M.

The injured are to be disposed as follows: One lying on sidewalk on Northwest Corner of 8th and Olive---this person is suffering from a severe head injury; One lying on the sidewalk north of the service station---he has a spinal injury and a bloody wound in the calf of his left leg; One is lying on the sidewalk south of the demolished building on the northeast corner, and when extricated he will be found to have a crushed chest and a wound in his neck which is bleeding profusely.

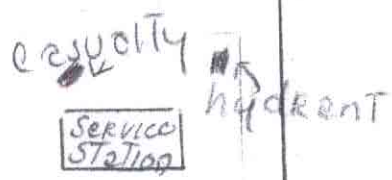
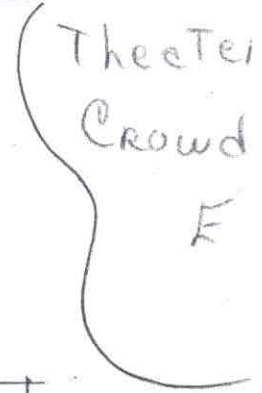
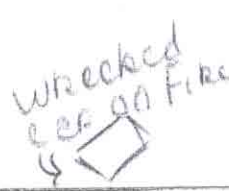

#2 INCIDENT IN DISTRICT B

1. PLACE: Seventeenth Avenue West between Charnelton & Lincoln.
2. TIME: Setup -- 7:20 P.M. Incident -- 7:30 P.M.
3. MATERIALS: ~~One truck loaded with planks and horses for barricade to simulate bomb rubble;~~ line for bomb crater; wires to indicate "hot" wires; one wrench to open hydrant; cars or materials to simulate wrecked cars (two are sufficient) one car to overturn in middle of intersection.
4. PERSONNEL: One truck driver; three persons to act as casualties; a half dozen persons to simulate residents congregated in street.

5. DESCRIPTION OF INCIDENT:

Truck driver with the above materials and personnel will leave 101 West 5th street in time to complete the setup of the incident by 7:20 P.M.

Truck with materials and personnel will proceed to place as indicated on map above; Make a 30-foot circle with line to indicate bomb crater; ~~place barricade to simulate bomb rubble;~~ place material to simulate wreckage of cars as shown on map; place overturned car in middle of intersection; place wires on sidewalk south of grocery to simulate "hot" wires down; open fire hydrant.

The injured are to be disposed as follows: one beneath car overturned in intersection of Lincoln and 17th--he is unconscious but otherwise not injured; one lying on sidewalk east of third house from the grocery store--he has an abdominal wound; one lying on grass alongside northwest wall of Eugene High School--he has a shattered thigh.

6. TIME INCIDENT CLOSED: 8:00 P.M. N
