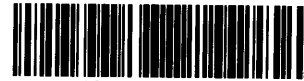
b. Fictive filing with county recorder. Enclose recording fee of \$3.00 per page.


