Tri-County Gun Club Constitution

Revised and adopted August 13, 2003

Article 1: Name

The name of this organization shall be Tri-County Gun Club.

Article 2: Purpose

The purpose of this organization shall be:

- To promote the safe use of firearms for marksmanship, sport and competition including shotgun,
 rifle, and pistol; to provide the grounds, ranges and other facilities therefore; and to train members and youth in the safe and proficient use of firearms.
- To promote rifle, pistol and shotgun matches for members and teams, and to affiliate with the National-Rifle Association and other organizations of sporting or competitive marksmanship.
- To support and promote environmental conservation and the propagation of wildlife and wildlife habitat.
- To promote good citizenship; to support the Constitution of the United States of America; and to conduct other lawful activities of a non-profit nature for the achievement of the objectives and purposes above.

Article 3: Membership

The membership shall consist of sportsmen and sportswomen 21 years of age and older who may legally own firearms and meet the requirements for membership as set forth in the Bylaws.

Article 4: Organization and Offices

The Executive Board of this club shall consist of the following elective offices which shall manage and conduct club business as set forth in this Constitution and the club Bylaws.

- a) President
- b) Vice President
- c) Membership Secretary
- d) Recording Secretary
- e) Treasurer
- f) Executive Range Officer
- g) Sergeant at Arms
- h) Director 1
