To All to Whom These Presents May Come, Greeting:

Know Dt, That whereas

WILLAMSTIE UNIVERSITY

a corporation organized and formed under and pursuant to the Laws of the State of Oregon, having presented Supplementary Articles of Incorporation, and paid the filing fee, as provided by Chapter 126, General Laws of Oregon for 1915;

How, Cherefore, I. E. B. Manuer, Corporation Commissioner of the State of Oregon, DO HEREBY CERTIFY, that said

Supplementary Articles of Incorporation

ARTICLE IT-

The title of the trustees making these Supplementary Articles of Incorporation is "board of Trustees of Willamette University," and the mode and times of the elections of their successors in office shall be as follows:

By the Board of Grustees of Willamette iniversity six members;

by the Cregon Conference of the Methodist Episcopal Church, Twelve members;

By the Columbia Liver Conference of the Methodist Lipiscopal Church,

three members;

By the Idaho Conference of the Mathodist Episcopal Church, three members; By the alumni Association of Willamotte University, six members; By any other conference of the Mathodist Episcopal Church wishing to

affiliate and give its patronage and support to the said University, one member.

Each of the above mentioned members of the Board of Trustees shall be elected and serve for a term of three years, and the body by which the respective trustees are elected shall have authority to elect their successors and to fill all vacancies as their respective terms expire, or vacancies occur from any other cause. In president of said University shall be a member of the Board of Irustees ex officio.

and in the manner provided for in the by-laws, and the trustees and visitors elected by the several conferences and the Alumni Association shall be elected at their annual meetings. Each of the above mentioned conferences shall have authority to elect three visitors, who shall have the privilege and authority of attending any meeting of the Beard of Trustees, and of speaking on any question under discussion, but shall not have the power to make any motion or to vote.

Andh affiliating conference above mentioned shall elect one visitor as above defined. Provided, that the members now serving shall continue to be members until their terms for which they were elected shall expire.

SUPPLEMENTARY ARTICLE OF INCORPORATION

OF

" WILLAMETTE UNIVERSITY.

KNOW ALL MEN BY THESE PRESENTS:

That We Amedee M. Smith, E. T. Barnes, l. T. Revnolds.
A. A. Lee and I. H. Van Winkle,

with the usages and regulations of Willamette University, and that we make and subscribe the following supplementary article of incorporation in triplicate, having been duly authorized by resolution adopted by unanimous vote of the members of said Board of Trustees present at the annual, regular meeting of said Board, held at Salem, Oregon, on the 12th day of June, 1926, at ten o'clock, A.M., at which meeting there was a full quorum of said Board of Trustees:

Article IV of the Articles of Incorporation of Willamette University, shall be and the same is hereby smended so as to read as follows:

ARTICLE IV.

The title of the trustees making these Supplementary Articles of Incorporation is "Board of Trustees of Willamette University," and the mode and times of the elections of their successors in office shall be as follows:

By the Board of Trustees of Willamette University, mix members:

By the Oregon Conference of the Methodist Episcopsl Church, twelve members;

By the Columnia River Conference of the Methodist Episcopal Church, three members;

By the Idaho Conference of the Methodist Episcopal Church, three members;

By the Alumni Association of Willamette University, six members;

By any other conference of the Methodist Episcopsl Church wishing to affiliate and give its patronage and support to the said University, one member.

Trustees shall be elected and serve for a term of three years, and the body by which the respective trustees are elected shall have authority to elect their successors and to fill all vacancies as their respective terms expire, or vacancies occur from any other cause. The President of said University shall be a member of the Board of Trustees, ex officio.

The Trustees elected by the Board of Trustees shall be elected at the time and in the manner provided for in the by-laws, and the trustees and visitors elected by the several conferences and the Alumni Association shall be elected at their annual meetings. Each of the above mentioned conferences shall have authority to elect three visitors, who shall have the privilege and authority of attending any meeting of the Board of Trustees, and of speaking on any question under discussion, but shall not have the power to make any motion or to vote.
