HB 2570 – PUBLIC HEARING

031 Heidi Moawad Counsel. Introduces HB 2570, which requires Oregon Youth Authority (OYA) to establish system of structured, intermediate probation violation sanctions that may be imposed by juvenile department counselor or youth authority.

037	Christina McMahan	Oregon District Attorneys Association, Deschutes County Deputy District Attorney. Submits proposed amendments (EXHIBIT A) and testifies in support of HB 2570. Offers background for the bill.
086	McMahan	Suggests waiting for a work session until stakeholders can all be involved in the discussion.
090	Olson	Asks how long it takes Deschutes County to resolve juvenile probation violation cases.
093	McMahan	Estimates that it takes two weeks to a month to resolve the case, as there are typically three hearings.
102	Timothy Travis	Oregon Judicial Department. Testifies that the fiscal impact of HB 2570 may save the state some money. Discusses different viewpoints of judges regarding HB 2570.
153	Travis	Continues discussion of judicial function. Suggests a work group.
168	Travis	Mentions that in most places in Oregon a probation violation sets off one hearing, not three as in Deschutes County.
174	Moawad	Asks about adding language that would address some of his concerns.
182	Travis	Describes the aspect of the bill that allows judicial discretion.
202	Mary Botkin	American Federation of State, County, and Municipal Employees (AFSCME). Testifies neutrally, and suggests putting one of AFSCME's parole officers on the work group for HB 2570.
228	Barker	Asks counsel to get a work group together. Closes the public hearing on HB 2570.
236	Barker	Adjourns the hearing at 8:54 a.m.
