002 Chair Butler Calls meeting to order at 1:30 p.m.

005	Mazen Malik	Gives overview (Exhibit 1). Bill originally discussed on 1/31/05. It increases the housing revenue bond limit to \$2.5 billion. Notes a difference in revenue impact statement (Exhibit 2) from previous impact statement because of a change to the funding mechanism.
045	Chair Butler	Comments that with higher interest rates there would be more demand for the program.
053	Malik	Responds that most likely higher interest rates and higher costs of homes will increase the need for low income housing.
065	Chair Butler	Asks for further questions from committee members.
077	Rep. Boquist	Asks if there is an impact on the general fund.

		Responds that there is no impact. The amounts of the debt and the bond proceeds are considered "non-limited" funds because they come in and go out at the same time.
080	Rep. Boquist	Asks for clarification of term "built-in" pertaining to the state economist's model for this program.
090	Malik	Explains that the state economist projects the number of new housing units and construction jobs that would be created based on the already established or "built-in" structure of the housing bonds.
108	Rep. Boquist	MOTION: MOVES HB 2052 TO THE HOUSE FLOOR WITH A DO PASS RECOMMENDATION AND BE REFERRED TO THE WAYS AND MEANS COMMITTEE.

125MalikGives overview (Exhibit 3). This bill was heard originally on 1/31/05.
It allows a threshold limit from \$150,000 and establishes Housing
Council rules. Also extends the maturity period on Housing bonds

from 42 to 47 years. Discusses new fiscal analysis (Exhibit 4) concluding that the fiscal impact is indeterminate because the amount of needed housing is not currently known.

215 Paul Warner Gives overview (Exhibit 5). This is the first of a series of reviser's bills that will be reviewed by the committee. It corrects errors and repeals obsolete material in the tax statute.

234 Dexter Johnson Discusses changes proposed. During the interim his staff identifies certain inconsistencies and technical mistakes in the statutes, and HB 2446 seeks to correct language in the tax statute. This bill is a little different in that there is a "note" at the end of each section that describes what changes have been made.

260	Chair Butler	Asks about some of the wording changes, for instance, rural enterprise zone in section 2, page 3, line 17.
276	Johnson	The substance of the section is the same as what the language replaces. He also reviewed the changes with the Dept. of Revenue, and they agree that there are no substantive changes other than to improve the wording.
320	Rep. Boquist	Asks about page 19 that defines tangible personal property that does include livestock. Refers to previous committee discussions about taxing livestock.
339	Johnson	Explains that this is existing law. It only includes livestock as tangible personal property. It eliminates the "unless otherwise specifically provided" language, which does not conform to legislative form and style.
384	Rep. Riley	Comments that he wants to ensure that the right choice of words is utilized when making these changes.
400	Rep. Boquist	Asks again about the tax exemption for livestock. Why not eliminate the word livestock in the text if there is already an exemption for it?
415	Johnson	Responds that in the future if there was a decision that tangible personal property would be subject to tax that unless someone remembered that livestock was included in the definition, livestock would remain exempt.

443	Rep. Boquist	Requests clarification on section 73, page 40, that referees for soccer matches are considered independent contractors. Should referees for other sports be included?
452	Johnson	Reviews additional information in sections 115 and 116, page 60, and provides history of previous legislation affecting this section.
