002 Chair Butler Calls meeting to order at 1:05 p.m.

OPENS PUBLIC HEARING FOR HOUSE BILL 3441

024	Sam Adams	Submits Fact Sheet handout in support of HB 3441 (Exhibit 1). Explains the different budget committee processes in the City of Portland versus other municipalities.
045	Chair Butler	Asks if other entities such as the League of Oregon Cities or the Assn. of Oregon Counties would be commenting on this bill.
048	Adams	Responds that this bill only affects the City of Portland and potentially community colleges.
053	Rep. Berger	Comments that there is a unique budget process in Multnomah County affecting municipal employees. HB 3441 allows the county to change their budget committee process, but does not mandate it.

062 Adams Adds that the 1963 legislation only affected Multnomah County. HB 3441 would allow Mt. Hood Community College, Portland Community College, and the City of Portland the option of adding citizens to their budget committees.

OPENS PUBLIC HEARING FOR HOUSE BILL 2257

- 097 Lizbeth Martin-Mahar Explains that this bill corrects technical changes in the statute pertaining to bonds.
- 116Rep. BoquistExpresses concern about the wording change proposed between
"shall" and "may" in line 9 of the bill. Comments that he would like
to have someone from Legislative Counsel explain the wording
change.

OPENS PUBLIC HEARING FOR HOUSE BILL 2251

134 Martin-Mahar Gives overview of HB 2521 (Exhibit 2). Refers to Issue Brief (Exhibit 3) that gives a detailed chronology of legislation pertaining to public sector retirement income and taxation. Adds that in current

law, local government plans must be equal to or better than the Public Employee Retirement System (PERS) benefits.

174	Chair Butler	Asks how many plans are affected.
185	Michelle Deister	Responds that there are 240 cities in Oregon, and 170 are members of PERS. There 7 cities with "equal to or better than" (ETOB) plans for fire and police employees. There are some cities so small (one full-time or part-time employee) that do not offer any kind of pension plan. Will provide revenue impact information to Martin-Mahar.
214	Marge Kafoury	Testifies in support HB 2521. It puts the City of Portland's fire and police employee pensions on par with PERS in that both will be exempt from Oregon income tax in accordance with previous legislation affecting pubic sector pensions.
223	Chair Butler	Comments about previous lawsuits filed on behalf of other public employees who were being treated differently on their pension benefits. Asks if there are current pending lawsuits from affected public sector groups.
235	Deister	Responds that she believes that HB 2521 is linked to legislation following passage of HB 3349 enacted in 1995.
250	Chair Butler	General comments about previous pension legislation. Recommends seeking counsel from the attorney general's office on this bill.

274	Rep. Riley	Comments about the language "equal to or better than PERS." Asks about employees who are not at the same level as PERS employees.
276	Kafoury	Responds that the statute was amended many years ago requiring fire and police non-PERS employee benefit plans to be equal to or
		better than those of PERS employees. There are periodic reviews done to compare PERS and non-PERS pension plans.
300	Deister	Adds that some local governments are so small that they can only offer their employees other non-PERS plans. Whether they are more or less equal to PERS depends on "who you ask."
309	Rep. Berger	Comments that the situation regarding federal employees may be a different issue than the issues addressed in HB 2521. Recommends seeking more information on this issue.
330	Chair Butler	Agrees with Rep. Berger and requests more information on this bill.
