010	Dale Penn	Director, Oregon Lottery Commission (OLC). Submits copies of Oregon Lottery PowerPoint presentation (EXHIBIT A). Submits copies of Oregon Lottery Strategic and Business Plan report (EXHIBIT B). Discusses the purpose and business plan of the lottery.
033	Penn	Reviews the organizational structure, history and Constitutional authority of the OLC (EXHIBIT A, Pages 4 - 5).
066	Penn	Explains the sources of lottery funds, how the legislature distributes lottery monies and the OLC budge process (EXHIBIT A, Page 6).
129	Penn	Describes the different types of lottery games and the administrative costs of each game, specifically addressing the amount of short term and long term revenues generated (EXHIBIT A, Pages $8 - 11$).
185	Penn	Explains how OLC is a self-supporting agency that requires the maintenance of a reserve fund to meet administrative, capital, and operational costs (EXHIBIT A, Pages $12 - 13$).
255	Penn	Discusses the audit conducted by the Secretary of State and the continuous internal audits administered by OLC (EXHIBIT A, Page 14).
280	Penn	Reviews The Governor's recommended budget for 2005-07 (EXHIBIT A, Pages 15 – 17).
339	Penn	Addresses a survey conducted by the OLC that indicates that Oregonians support the addition of line games.

066	Penn	Explains the efforts of the OLC to fund gambling treatment programs. Acknowledges that when OLC expands the number of lottery games there will is an increase in problem gambling,
151	MardiLyn Saathoff	General Counsel, Office of Governor Kulongoski. Speaks to the Governors' views on the lottery, particularly with regards to line games. Verifies that: The Governor has requested that OLC expand to line games.
201	Saathoff	Addresses whether The Governor has the legal authority to let the OLC to add line games.
208	Rep. Nelson	Asks if The Governor wants to make permanent the 15 percent lottery fund appropriation for the Oregon State Patrol.
216	Saathoff	Affirms that the Governor would like the 15 percent to be on going, but that is a manner for the legislature to decide.
234	Saathoff	Discusses Indian gaming and the status of the negotiations with The Confederated Tribes of the Warm Springs Tribe over building a casino in Cascade Locks.
291	Rep. Merkley	Questions the constitutionality of designating 15 percent of the lottery revenue to the Oregon State Patrol.
298	Saathoff	Explains why funding the Oregon State Patrol is considered to be a vital component of economic development.
364	Saathoff	States that The Confederated Tribes of the Warm Springs Tribe will move to Hood River and build a casino if the negotiations over Cascade Locks location and subsequent regulatory issues cannot be resolved.

072	Penn	Explains why increasing the number of \$1 million dollar lottery drawings would not expand economic recovery in Oregon.

341	Penn	Addresses the administrative costs associated with the OLC, in particular the costs of "payouts" and retailer compensation.
375	Rep. Nelson	Questions why the OLC has the lottery tickets produced in Texas.
400	Penn	Explains that the manufacturing of Oregon Lottery scratch-it tickets is outsourced to a facility in Texas for security reasons and lack of cost effectiveness.
