Testifies in support of SJM 1, which urges that Congress and Secretary of Defense authorize and appropriate funding to attain 75 percent of full-time manning requirements for Army National Guard and that Secretary of Defense report to Congress in 2005 fiscal year on plan to meet 100 percent of full-time manning requirements by end of 2008.

280	Caldwell	Explains that full-time manning levels vary amongst states based upon pentagon strategy.
320	Caldwell	Speaks to the issues and reasons surrounding the Department of Defense plan for the realignment and closure of military bases in Oregon.
