005 Chair Deckert

Calls meeting to order at 9:07 a.m. Committee will continue work on SB 841-A which establishes a reserve fund.

WORK SESSION, SB 841

019 Chair Deckert Resumes discussion of an open motion made April 14 to adopt SB 841-3 amendments. The discussion was whether the money should go to the general fund after the 5% cap is reached in 2010, or be placed into the school capital matching grant, which is where it would go today.

- 032 Sen. Metsger Supports moving SB 841-4 amendments (**EXHIBIT 1**). He has argued that it would be a good idea to establish a separate and distinct reserve fund, even though the stability fund accomplishes that purpose. Lawmakers have not articulated well to the public that this accomplishes it. A stability fund is fine. The problem is, if the economy ticks upward, the state could meet the 5% cap in 48 months. That would not build the fund to the point where state wants it to go. Concerning raising the cap in the future, why wait? Suggests sending it to the voters in two years, since they support the idea of saving money while supporting education. Supports moving SJR 19 simultaneously with this amended bill to increase the cap.
- 061 Chair Deckert Clarifies SB 841-3 contains a stability fund and excess after 5% goes into the general fund. SB 841-4 amendments say status quo. Third, as proposed by Sen. Metsger, is going to the voters. Asks for further discussion.
- 071 Vice Chair C. Starr Comments, the need for a stability fund or reserve fund is bipartisan. It would be wise to move ahead with this and convince the public of the need to raise the cap. Supports Sen. Metsger's proposal.

085	Chair Deckert	The question is whether to go to voters now and risk losing the vote, or go to them later.
090	Sen. Prozanski	Prefers taking it to voters now, so lawmakers will know what they have to do in the 2007 session. People might be more receptive now, before the economy becomes strong again. Supports Sen. Metsger's proposal. Suggests Sen. C. Starr rescind his motion for SB 841-3 amendments.
104	Sen. George	This is a great idea. Looks as though all were thinking in the same direction.
