- 090 Steve Vincent Thanks lawmakers for adopting electronic commerce zone incentive into statute. It has created 2,300 new jobs in Medford and added \$7 million in capital construction. Asks committee to withdraw Sen. Prozanski's proposed HB 2234-C12 amendment. Explains, Murphy Plywood burned down and proponents are trying to find a solution to waive it from its contract to increase jobs. Asks for passage of the bill.
- 135 Sen. Prozanski Explains what HB 2234-C12 is trying to do. Another bill, HB 3143, is an alternate vehicle for this change. Expresses concern with language on page 4, lines 1-4.
- 166 Chair Deckert Suggests drafting language for the specific situation at Murphy Plywood.
- 171 Sen. Prozanski Agrees. Lawmakers can discuss a "global" fix during the interim.
- 177 Art Fish Urges the committee to adopt the HB 2234-C11 amendment which makes technical clarifications with respect to long-term enterprise zone tax credits.
- 191 Chair Deckert Is ready to move this bill.
