Explains that they will be working on only one of the Higher Education bills today regarding Operations.

Whitsett Indicates that the projected budget this year would be a continuation of the phase down. 163 Nancy Heiligman Believes the program is at a sustainable level at this point. 172 Bill McGee, Dept. of Makes a clarification that it was a correction to the essential budget Administrative level. Services Sen. Whitsett Indicates he believes he understands it. 178 182 Steve Bender Refers the committee members to the memorandum (Exhibit #2) discussing the figures in the Operating Budget Totals charts. 197 Steve Bender Reviews the first recommendation in Exhibit #2 titled "Package 801 - LFO Analyst Adjustments. 205 Sen. Nelson Clarifies that it isn't actually a reduction. Comments on the attorney general rate; informs that it represents approximately a 12% increase. Asks what a savings it would be if it were only a 5% increase. 215 Chair Devlin Responds that in this budget the reduction would be approximately \$121,000. 233 Sen. Nelson Indicates he would choose the students rather than paying attorneys more money. 238 Steve Bender Confirms that the entire memo discusses changes to the Governor's Recommended Budget. 257 Steve Bender Reviews the LFO recommendation #2 which is Package 802 -Ways and Means Adjustments. Informs that LFO recommends that the Subcommittee increase the Lottery Funds expenditure limitation by \$182,345 and also that the Subcommittee acknowledges the following beginning balance and revenue revisions: reduce the beginning balance by \$56,399 and increase Lottery Fund revenue by \$558,741 to reflect revised revenue projections. 286 Sen. Walker Comments about a bill on Sports Action Lottery. 290 Chair Devlin Indicates that the bill is in the Senate and hasn't come to the floor. 292 Sen. Walker Believes it was created by constitution. 294 Steve Bender Responds he believes it was statutory. 300 Sen. Walker Asks if the bill passes how that would impact this budget. 302 Steve Bender Replies that an adjustment would have to be made to the Higher Education Budget. 306 Sen. Walker Understands what he is saying. Asks should the measure pass would that be done by the Emergency Board. 313 Chair Devlin Comments about the adjustments that would be done to modify the budget. 321 Sen, Walker Asks if it makes it revenue neutral. 323 Chair Devlin Responds he doesn't know if it does that and then elaborates.

Gordly Asks which agencies they are speaking about. Asks if there are other options for those agencies. 331 Replies that she doesn't have that type of detail. Nancy Heiligman 335 Thayne Dutson, Explains that their scientists work with the institute and provides data Director Oregon for state agencies like the Watershed Enhance Board, etc. Agricultural Experiment Station, Oregon State University 360 Chair Devlin Indicates that this is version 2 of the OUS budget and there will be a version 3 and he thinks that there will be an understanding reached on this budget item. 368 Sen. Gordly Clarifies that the \$250,000 is part of an existing budget that supports the Natural Research Institute. 371 Nancy Heiligman Indicates that the funding wasn't included in the OUS budget in the current biennium. 381 Sen. Gordly Asks if that would totally de-fund the institute or are there other funds to allow the work to be carried forward. Nancy Heiligman Indicates that it would severely limit and restrict their operations. 387 394 Sen. Gordly Indicates that it would be another impact. 397 Bill McGee, Dept. of Explains that it is continuing in the same funding level. Administrative Services 403 Steve Bender Covers recommendation #11 titled "Package 112 – Forest Research Laboratory Expenditure Limitation Increase. TAPE 9B 007 Steve Bender Comments on HB 2122 which would deal with the sunset and informs that the House passed that bill in an earlier meeting today. Steve Bender 018 Reviews recommendation #12 which is Debt Service on PSU City Tower (Package 117). 036 Steve Bender Moves to Package 813 – Program Reductions noting that LFO is recommending approval. Discusses the five areas where the program reductions are proposed to be implemented. Asks Mr. Bender to draw the connection between the fee remission 067 Sen. Gordly decision and the earlier fee remission cap decision in Package 108. 072 Steve Bender Responds that there is no direct relationship and then elaborates. 088 Steve Bender Continues his overview of the Program Reductions under Package 813 discussing the Campus Public Service Programs. 102 Chair Devlin Discusses what the Senate Co-Chair had previously planned. Asks how it would restore their budget. 204 Steve Bender Replies that the budget would not allow them to continue all of their work and it is not a full restoration. 225 Sen. Whitsett Clarifies that it would continue to decrease the number of FTEs and funding. 227 Steve Bender Agrees. Reviews Package 815 – Tuition and Fee Rate Adjustments. Informs that approval of the package would allow average tuition and resource fee increases for resident undergraduate students to be limited to 3% the first year of the biennium and 3% the second year. Sen. Whitsett Asks Mr. Bender to compare the Opportunity Grants to what is in the 270 House Budget currently. Steve Bender Indicates that the House Budget doesn't have the addition in it for 274 the Opportunity Grant and then further explains the differences in the House budget. 281 Steve Bender Discusses the corresponding Budget Note to Package 815 found at the top of page 8 in Exhibit #2. Reads the LFO recommended Budget Note into the record. 326 Chair Devlin Informs that they have reviewed the first 15 recommendations and agrees to accept a motion to approve all the Packages with the corresponding budget notes. 332 Sen. Gordly MOVES to approve all 15 of the LFO recommended Packages including any budget notes. 333 Sen. Walker Thanks Mr. Bender for the last Budget Note and for including the

energy surcharge fee.
