Tape / Counter Speaker Comments 340 Chair Devlin Indicates that the one page sheet which is a part of Exhibit #4 is the summary document. 351 Sue MacGlashan Clarifies that Exhibit #4 came from the progress board. Also refers to Exhibit #5 discussing the projected targets and how they differ. Indicates that the targets do need to be reviewed by someone because she is unaware where the targets on the one page document came from. Chair Devlin 389 Believes he may be able to clarify that when they get to that point. Sue MacGlashan 393 Makes further clarifications regarding the performance measure documents (Exhibit #4 and #5). Explains that she doesn't agree with the deletion of performance measure #7. TAPE 1B 005 Sen. Gordly Refers to page 9 in Exhibit #5 discussing the target and asks how the targets were set as the data was unknown. 014 Chair Devlin Replies that it was a target that was set and then determined they had no way of tracking the target that was set. Vickie Chamberlain Agrees that he is partially correct and then explains that she had to 018 determine the targets within about 3 weeks back in 2003. Explains that they had very ambitious goals. 044 Chair Devlin Explains the way that the committee could proceed. 075 Sen. Walker Agrees with that process except this is an agency that has mandatory reporters. 078 Chair Devlin Requests that they can get on the budget report some language indicating to the agency to present to the audits committee a performance measure on training. Sen. Walker 084 Responds regarding mandatory reporters being under four areas of the statute, child abuse, sex abuse, elder abuse, etc. She wants to see performance measures developed for every licensing board and commission that has a mandatory reporter that has overview over a mandatory reporter so that they are adequately trained. 092 Chair Devlin Explains that it is an on going issue. Sen. Walker 097 Adds that if they are not getting the training, why not. 099 Vickie Chamberlain Responds that she understands completely and believes a budget note would be fine. Believes that if it was in statute it would be implemented quicker. Sen, Walker 111 Replies that they have it in SB 49 if it gets out of Ways and Means. Chair Devlin 114 Clarifies that they are not suggesting a budget note this is part of the budget report. 120 Sen. Gordly Indicates she doesn't know if she is comfortable adopting the performance measures as presented. States she would be comfortable directing that the agency report to the Joint Legislative Audit Committee for its review of the performance measures and targets. 132 Chair Devlin Explains that they were given two choices and then elaborates. 140 Sen. Gordly Indicates that she is seeking help on a motion that would be directed to the agency reporting its progress, its work, to the joint legislative

audit committee.
