187	Steve Bender	Discusses SB 5584 which is the blank bill for the Oregon Student Assistance Commission (Exhibit #7). Explains that the details of the Bill that they approve is put into a Budget Report which will provide the details.
238	Steve Bender	Covers the first LFO recommendation which is Package 202 titled the "ASPIRE Program". Explains the ASPIRE Program and indicates that it is entirely funded by Other Funds. Explains that LFO is recommending approval of the package with modifications. Refers to Exhibit 4 on page 6 of 15 which lays the information out in more detail. Discusses the reason why the agency proposed the adjustment. Explains that passing the Package would allow the agency to continue the program as it is currently. Informs that if donations turn out to be more than expected they can come before the Emergency Board with a request to spend the donations.

Chair Devlin 356 Responds yes. Steve Bender Covers the Oregon Financial Aid Exchange (OFAX) (Package 300). 357 Indicates that LFO is recommending approval. 382 Chair Devlin Indicates that he will ask for a motion to approve the LFO recommendations after reviewing all of them. 389 Steve Bender Reviews the LFO recommendation #3 which refers to Package 801 (LFO Analyst Adjustments). Explains the two adjustments that will be found in most budgets. Discusses the over-funding of PERS contributions in all budgets and thus explains the need for the adjustment. TAPE 3A Steve Bender 012 Indicates that they put all of the reductions for the Attorney General in Package 811. 015 Steve Bender Reviews the fourth item in Exhibit #1 which is Package 802, Ways and Means Adjustments. Indicates that LFO recommends that the Subcommittee reduce Federal Funds expenditure limitation by \$1,051,930. 060 Steve Bender Explains that the agency can come before the Emergency Board if needed. Sen. Walker 064 Asks when Congress will finally approve the budgets. 066 Steve Bender Responds that it varies. Sen. Walker 067 Comments that it varies so it could be in the Fall, etc. 070 Steve Bender Indicates that it would most likely be in the Fall. Explains the LFO recommendation which would be to allow the agency spend every dollar received from the Federal program. 079 Sen. Gordly Notes that it is important that they communicate to their Congressional delegation about the loss and demise of these programs. Believes it may have already been expressed by others in their body. If not, she would recommend it be expressed. 098 Chair Devlin Agrees to discuss it and see what form it would take. Doesn't know if there would be agreement within the committee. Discusses the larger issue which is about Pell grants in general. Believes it has more significant impact that these two programs. 108 Sen. Gordly Indicates that there is a whole list of programs that are affected.
