Tape / Counter Speaker Comments 156 Reviews Package 812: Special Budget Committee Adjustments #2 Doug Wilson explaining that LFO is recommending approval of the package. 173 Chair Gordly Asks what outcomes that they are expecting with that small investment. 179 Craig Prins Replies regarding prevention of methamphetamine and believes the package will get to that issue. 186 Chair Gordly Clarifies the question that she was asking about regarding the Oregon partnership. 190 Replies that they are putting together a TV campaign for public Craig Prins service announcements as well as radio ads. Explains that they will also be putting together community kits for use in educating about methamphetamine. 209 Covers page 8 of 9 in Exhibit #1 discussing the Juvenile Crime Doug Wilson Prevention unit. Covers Package 070: Revenue Shortfalls. 216 Reviews Package 104: Fully Fund Merit Increases. Doug Wilson 222 Doug Wilson Covers Package 105: Increase FTE (.09) Position #10. 230 Discusses Package 300: Transfer Juvenile Crime Prevention Doug Wilson Grants. 242 Chair Gordly Asks how it is reflected in the House Budget plan. 245 Doug Wilson Responds it fully funds the transfer. Believes that the Senate cuts it back to 2 or 3 million for the Juvenile Crime Prevention. 248 Sen. Devlin Clarifies about 4 million. 249 Doug Wilson Indicates it is cut in the Senate version. 254 Refers back to the memo (Exhibit #1), page 2 discussing the Doug Wilson bulleted points titled "Outstanding Issues". 269 Chair Gordly Asks if the co-chairs are fully aware of both of the issues and the fiscal impact. 273 Doug Wilson Replies that he doesn't believe that they have talked about it. 279 Craig Prins Clarifies the question and indicates that if nothing happens legislatively and measure 3 is overturned they would be able to civil forfeiture as it was done before measure 3 which would mean that there would be money coming into the state. 309 Speaks about the conversation she had with Mr. Olson about the Chair Gordly split regarding drug cleanup. 319 Explains as the meth proposals come through they need to look at Doug Wilson how drug courts may be funded through the proposal and then elaborates. 334 Chair Gordly Asks if the House has the same level of awareness. 336 Doug Wilson Agrees to speak to them about the drug courts. Comments on the second bulleted item under "Outstanding Issues" 339 Doug Wilson in Exhibit #1. 349 Doug Wilson Covers the final bulleted item under "Outstanding Issues" reviewing the budget note that is being recommended.
