SB 232 – RELATING TO JUVENILES PUBLIC HEARING 091 Chair Gordly STANDS AT EASE 094 Chair Gordly Reconvenes the meeting. 096 Deborah Manthe, Explains what the measure does. Refers to (Exhibit #3, Staff Legislative Fiscal Measure Summary), (Exhibit #4, Senate Bill 232). Office 107 Senator Kate Brown, Provides some background information to the committee on SB 232. District 21 Refers to (Exhibit #5, Juvenile Code Revision). Introduces two parties with her today.

Karen Andall Responds that they believe there could be two youth currently in their system that would potentially fit under the rule.

Kathy Berger Comments about how many youth that would be there. Indicates that they came up with a figure of 10 youth in a biennium.

Sen, Kate Brown Adds that they believe the youth are already in the system either in OYA or in foster homes. Discusses two other bills that came before the Senate. (SB 1059 and HB 2141).
