013	Doug Wilson, Legislative Fiscal Office	Notes memorandum ( <b>Exhibit #2, memo and –A5 amendments dated 7/18/05 from Doug Wilson, dated 7/18 2005</b> ), handout ( <b>Exhibit #3, from Chief Jeffrey Johnson, dated 7/18/05</b> ) and amendments ( <b>Exhibit #4, -A4 amendments dated 7/15/05</b> ).
025	Sen. Rick Metsger	Senate District 26. Comments on the coordination of emergency management agencies.
050	Chair Gordly	Comments on urgency and deficiencies of the communication between emergency management agencies.
056	Ken Murphy	Director, Oregon Emergency Management & Deputy Director, Oregon Homeland Security. Submits written testimony ( <b>Exhibit #5, intent and goals of SB 817A, dated 7/18/05</b> ). Explains amendment. Discusses public safety communication. Explains narrow band technology.
105	Murphy	Continues explanation of improved technology. Comments on improving current systems instead of buying everything new.
151	Murphy	Continues discussion of interoperability.
173	Sen. Winters	Comments on communication gap in New York and Washington during the 9/11 attacks. Inquires what we have learned about communication technology since 9/11.
192	Murphy	Responds that computer technology can connect disparate systems so a new system is not necessary. States that more people should be connected to public safety systems than was traditionally thought.
231	Chair Gordly	Inquires about the public health side of the equation and where and when will public health be at the table as a partner.
242	Murphy	Responds that public health has recently been to the table. Relates that they are just emerging to address communication issues.
275	Chair Gordly	Questions timeline of initial Homeland Security Funding efforts.
285	Murphy	Explains timeline to identify problems and recommendations.
294	Chair Gordly	States that eight years is not much time. Inquires how much time “A-E” will take to complete ( <b>Exhibit #5, under “desired goals”</b> ).
299	Murphy	Believes that “A-E” will take at least a year. Comments on funding option for Homeland Security.
310	Sen. Winters	Comments on the loss of necessary communication during a disaster like 9/11. Questions who should be a part of the first

044	Chair Gordly	Vote: 2-0-1 Excused: Devlin Hearing no objections, motion <b>CARRIES</b> .

155	Sen. Winters	Inquires if the group home mentioned is in Albany.
160	Manthe	Responds that it was not identified in the fiscal analysis.
164	James Toews	DHS. States that a specific group home was not identified.

193	Toews	Comments on disability side, that the individual will probably continue into the adult system. States that statute sets conditions for sending juveniles to Psychiatric Security Review Board (PSRB).
211	Manthe	Explains impact on the Oregon Youth Authority. Notes that fiscal impact on Public Defense Services Commission and Oregon Judicial Department would be minimal.
226	Sen. Winters	Expresses concern for appropriateness of services provided to individuals with disabilities. States that concerns are allayed by response from DHS.
