069	Jim Voytko	Executive Director, PERS. States he will not indicate to the Board in the future they have the opportunity to credit above eight percent. Explains why.
089	Chair Knopp	Acknowledges comments of Voytko are accurate.
	Voytko	Advises committee that Johnson, Heynderickx, and he are in agreement. Explains future actions of the actuary.
106	Rep. Richardson	Asks if it is correct that the projections are based on 40 years.
	Voytko	Responds affirmatively.

	Voytko	Comments on requirements of the Board to set aside funds and the challenge is for the staff and Board to determine the amount for the reserve.

	Dallas Weyand	districts. Legislative Fiscal Office. Responds affirmatively and states they expect the school districts to come to the legislature for those funds.
165	Chair Knopp	Asks how much of a problem it would be for PERS to determine what
	Voytko	portion of the \$80 million is for each school district.Responds that the schools are pooled and PERS' knowledge is limited;it is probably not something PERS staff can produce in the appropriate timeframe.
	Chair Knopp	Asks how much staff time is needed.
	Voytko	States they will attempt to do it but they do not have comfort in committing to two weeks.
	Chair Knopp	Comments that he supports updating the PERS computer system to provide more information.
	Voytko	Explains what is needed to run figures on school districts.
229	Rep. Richardson	Asks if the present unfunded deficit is about \$17 billion.
	Voytko	Responds it changes every day; it was \$14.8 billion as of December 31, 2002.
	Rep. Richardson	Asks what the deficit might be currently.
	Voytko Steve Delaney	Comments that if the assumed rate is lowered to 7.5 percent, it means that from this point forward they expect one-half percent return on the assets. Explains that the funding stream must be replaced by some other funding stream. The only funding scheme that can be changed is employer rates; those would go up. Suggests the committee may want to look into "partitioning" to try to avoid that consequence by keeping the assumed rate and the investments that justify it at one level for most parts of the fund but not necessarily for some of the liability- generating parts of the fund which they would invest differently which would produce a lower expected rate of return. That would avoid the spike up in employer rates. PERS Legislative Liaison. Explains the \$17 billion figure.
	Voytko	Explains further the \$17 billion.
290	Brian Delashmutt	PERS Coalition. Reports that after consultation, they think the HB 2001-2 amendments are a good improvement and they are in support of the bill. Comments on the Legislative Fiscal Statement (EXHIBIT B).
310	Chair Knopp	Asks if Delashmutt believes further amendments will not be needed on the Senate side.
	Delashmutt	Responds he is comfortable with the bill in its current form, and Hartman is comfortable with it. Does not anticipate any changes in the Senate.
	Chair Knopp	Comments on agreements and moving forward.
338	J. L. Wilson	National Federation of Independent Businesses, Oregon (NFIB). States that employers are clear and adamant that PERS is most important and they endorse HB 2001 with the amendments.
	Joe Swinehart	Associated Oregon Industries (AOI). Speaks in support of HB 2001. States that AOI also supports the Governor's stand on mortality tables and changing the Board membership.
	Russ Walker	Northwest Director of Citizens for Sound Economy. States they are pleased with the efforts to reform PERS. Supports HB 2001 with the amendments and also supports the Governor's comments earlier today.

	Voytko Bon Richardson	Comments he believes the differences will be in the populations studied. States he does not believe their tables would be different than those used by an insurance company. Requests a copy of tables being used by PERS.

	Chair Knopp	Explains he feels there needs to be an age minimum in the bill.
	Filsinger	Explains HB 2005-2 amendments (EXHIBIT E).
081	Chair Knopp	Comments on Governor's desire for makeup of the Board. States that the amendment needs to be drafted. Adds that others are free to make recommendations.
	Rep. Macpherson	Notes there would be a position on the Board for labor and for management. Suggests those members hold the same fiduciary duties as those from the general public. Asks that the chair include that in the amendment draft.
	Chair Knopp	Responds he would be happy to accomplish Rep. Macpherson's suggestion if it is legal.
125	Chair Knopp	Comments he would like to go to work session on HB 2005 next Tuesday. Asks that members get their ideas together to prevent having conflicting amendments.
