221	Rep. Farr	Discusses conversation with Eugene school board in which it was pointed out that students meeting high standards might be cyclical and now that pre-Measure 5 students are graduating, the high education standards that have been met might decrease.
251	Rep. Verger	Asks why the schools will lose money if they don't comply with meeting standards.
267	Castillo	Responds that they will lose federal money if they don't comply with federal law and that there are strict timelines and guidelines.
303	Rep. Shetterly	Asks if it if just No Child Left Behind dollars that might be lost or all federal dollars.
307	Castillo	Responds that there are other dollars at risk, including Title 1 dollars.
313	Rep. Verger	Discusses views on federal mandates, the CIM and CAM, and the suggestions on raising revenues. Asks how the school community will demonstrate to the public that they are willing to share in the pain of the current situation.
391	Castillo	Responds that teachers are already making these sacrifices, such as in

Portland where the teachers have agreed to work for free for 10 days. States that the burden should not just be placed on the teacher's backs.

224	Rep. Farr	Discusses the education background of members of the committee and expresses that the comments and suggestions given by Castillo are in good hands.		
245	Castillo	Discusses a student advisory committee that was recently formed and suggests that the student committee testify before the revenue committee about funding issues.		
280	Brian Reeder	Introduces study performed by the Department of Education on small schools. Discusses the charge of the legislature in doing the study (Exhibit 2).		
310	Reeder	Discusses the objectives and approach of the study.		
390	Reeder	Discusses the relationship between high school size and cost per student.
