045	Chair Smith	Announces that HB 2298 and HB 2722 have been postponed. Closes the public hearing on HB 2691 and opens the public hearing on SB 170 and SB 171.

055	Kimberly A. Medford	Administrator. Provides an overview of SB 170 (EXHIBIT B) and SB 171, (EXHIBIT C).
064	Brenda Rocklin	Director, Oregon Lottery. Explains that SB 170 clarifies that currently the law does not express an age limit on video lottery games. Provides and example and explains the purpose of the bill. Testifies in support of SB 170.
091	Rocklin	Explains that SB 171 is a housekeeping bill and explains the purpose of the bill.
116	Rep. March	Asks who certifies the program that creates the random number pick.
120	Rocklin	Responds that the Random Number Generator (RNG) is in a locked room under the control of the Oregon State Police. Adds
