004	Chair Brown	Calls the meeting to order at 3:06 p.m. and opens a conference committee and work session on HB 2388B.
<u>HB 2388B WORK SESSION</u>		
010	Janet Adkins	Committee Administrator. Offers a description of the bill and the issues to be addressed by the conference committee. Enters into the record the –B3 amendments (EXHIBIT A).
035	Rep. Beyer	MOTION: Moves to ADOPT HB 2388B-B3 amendments dated 06/13/03.
040	Sen. Starr	Asks whether the used car dealers agree with the –B3 amendments.
045	Monty King	Executive Director, Oregon Independent Auto Dealers Association. Offers testimony in support of the bill as amended, including the issue that his group had with the bill before the amendments.
060	Rep. Beyer	Clarifies that the original revenue statement assumed the effects of the –B3 amendments were apart of the original bill, so therefore is unchanged by the amendments.
065	Adkins	Points out that there is already a process for selling out-of-state cars in Oregon.
070	King	Acknowledges, and further clarifies the process for selling out-of-state cars in Oregon.
072	Sen. Metsger	Comments on the practice of selling out-of-state cars.
075	Al Elkins	Oregon Tow Truck Association. Agrees with Rep. Beyer that the assumption had been that the language was already in the bill, but the -B3 just makes it more explicit.
080	Chair Brown	Hearing no objection, declares the motion CARRIED.
082	Rep. Beyer	MOTION: Moves HB 2388B to the floor with the

recommendation that the House CONCUR in Senate amendments dated 06/02/03 and that the bill be FURTHER AMENDED by adopting the –B3 amendments and the measure be REPASSED.
