OPENS PUBLIC HEARING ON SJR 7

012	Richard Yates	Explains SJR 7 which proposed an amendment to the Oregon Constitution to reduce the general fund match required to issue general obligation bonds under article 11-G. Exhibit 1.
030	Richard Jarvis	Testifies in support of SJR 7 because since the passage of Measure 5 Oregon universities have only received enough money from the general fund to complete six projects. Discusses proposed amendment. Exhibit 3.
064	Sen. Deckert	Asks why they want to move the date to general election of 2004 rather then the next primary.
066	Jarvis	Responds that they would be proceeding as anticipated in the next biennium and this would be moving with the current process.
066	Dave Frohnmayer	Testifies in support of SJR 7 because with record enrollment the university is exceeding capacity. Refer to written testimony. Exhibit 4. Explains that one reason to move the election to the general election is that they already have a major bonding issue to deal with deferred maintenance is already on the ballot.

103	Tim White	Testifies in support of SJR 7 because it would leverage more private investments in capital facilities. Refer to written testimony. Exhibit 5.
142	Sen. Deckert	Asks if the passage of SJR 7 would cause a decrease in private donations.
146	White	Responds that the needs are so great that the foundation would not become less aggressive in finding private donations.
161	Frohnmayer	Responds that it would be an incentive for donors because they would see the state stepping up to do its part.
176	Sen. Deckert	Asks if the Kelley investment would have been less had this law been in effect.
185	White	Responds that if there had been a different kind of match the investment from the Kelley group there might have been a broader investment.
189	Sen. Hannon	Expresses strong support for SJR 7 and a great appreciation for the work of university leaders.
236	Sen. Ringo	States that supporting higher education is the best economic development investment that the legislature can make.
255	Frohnmayer	Discusses study done that found a high return in the Oregon economy for every dollar spent.

307	Yates	Responds that he believes it would not affect those services.

340	Sen. Hannon	Asks if all taxes used to fund other programs would be taken for 911 funds.
349	Sen. Walker	Discusses the intent of the bill and states that it needs to be amended to narrow the scope. Expresses her support for SJR 30.

129	Sen. Deckert	Asks if there is an excess in funds since the extraordinary growth in cell phones.
136	Hatch	Responds that an increase in calls accompanied the growth in cell phones.

159 Kristina Wilde Responds that the FCC mandated that wireless lines have the same technology as hard lines so that callers can be located.

172 Sen. Ferrioli Asks if the bill excludes areas that do not have call centers and if it would

		exclude using the funds to build cell phone towers.
185	Squires	Responds that amendments are going to address what the funds can be used for.
191	Sen. Ferrioli	States that he supports SJR 30 but expresses concern that the entire state needs to be able to access the service.
		Discussion follows.
224	Sen. Corcoran	States that he doesn't like the fact that they are amending the constitution for this and expresses concern over the language.
234	Squires	Responds that the amendments would address that language.
272	Paul Snider	Testifies in support of SJR 30 because the telephone tax should be used for what it is dedicated for.
284	Sen. Deckert	Adjourns meeting at 2:20pm.
