OPENS PUBLIC HEARING ON HB 3183 A

015	Lizbeth Martin-Mahar	Explains the -A14 amendment, which modifies the single sales corporate apportionment formula and increases the maximum payroll tax rate for mass transit districts (Exhibit 1), and discusses the revenue impact (Exhibit 2). Discusses the modified singles sales factor apportionment and the impact on different industries (Exhibit 3).
070	Sen. Corcoran	Asks for clarification on the winners and losers under the single sales apportionment formula.
077	Martin-Mahar	Responds that it is the companies that don't have the property and payroll in Oregon that end up paying more. Explains the -A15 amendment, which includes the research and development credit (Exhibit 4), and discusses the revenue impact (Exhibit 5).
122	Sen. Metsger	Asks for clarification on the net change in revenue.
		Discussion follows.
134	Marcia Kelley	Testifies in opposition to HB 3183 A because tax credits that go into effect in future biennia should not be passed until tax reform has been addressed.

180 Bruce Bishop Testifies in support of the –B15 amendments (Exhibit 6), which creates a hospital provider tax, because it will allow the same providers to access to

		federal funds to maintain the Oregon Health Plan.
232	Sen. Metsger	Asks about the advantages for this legislation.
240	Bishop	Responds that it is not only an appropriate step for health policy reasons and fiscal reasons but most importantly for the healthcare needs of low-income Oregonians.
263	Sen. Deckert	Asks for a dollar figure associated with the federal funds that this would bring in.
266	Bishop	Gives an estimate of \$77 million in state resources and \$115-\$120 million in federal resources.
280	Sen. Deckert	Asks what the mechanics are for assessing the hospital tax.
282	Dayton	Responds that hospitals will be asked to complete a form that gives the Department the information they need to determine the amount of the assessment.
296	Sen. Nelson	Asks if this money is on top of the \$275 million that was in the Human Resources budget.
300	Bishop	Responds affirmatively and explains that the Human Services budget did not include a hospital benefit.
305	Sen. Nelson	Asks if there is any provision in the bill to help health clinics in rural areas.
312	Bishop	Responds that this bill is targeted to hospital care.
316	Sen. Nelson	Asks if there has been any discussion on the inclusion of other health care providers.
322	Bishop	Responds that the funds that are available here will go for the purposes of hospital payments.
329	Sen. Starr	Clarifies that this would allow hospitals to tax themselves in order to receive federal funds.
332	Bishop	Agrees with Sen. Starr.
349	Erinn Kelley-Siel	Testifies in support of the –B15 amendments because it will generate approximately \$57 million in state resources to increase capitation rates for Medicaid managed care organizations and to provide an emergency hospital benefit to the Oregon Health Plan standard population. Discusses the hospital assessment.

Discusses current and law and recent changes in federal estate tax law (Exhibit 10) and gives estate examples (Exhibit 11).
249	Martin-Mahar	Explains the –B20 amendments (Exhibit 12) which are the same as SB 313 and provides a \$2 million credit. Explains the –B18 amendments (Exhibit 13).
269	Debra Buchanan	Testifies that there needs to be a fix to the estate tax. Gives history of the estate tax in Oregon.
335	Sen. Corcoran	Asks Mr. Sheketoff to speak on the estate tax.
