003	Chair Clarno	Calls the meeting to order at 2:43 pm
005	Sen. Gordly	MOTION: Moves LC's: 9501, 9502, 9503, 9504 BE INTRODUCED as committee bills (EXHIBITS A – D).
012	Sen. Ferrioli	Asks if these are blank appropriation bills being introduced by the committee in case they are needed to rebalance the state budget.
017	Sen. Clarno	Says, yes.
019	Sen. Gordly	Points out that bill numbers have been assigned to these LC drafts.
020	Administrator Marjorie Taylor	Acknowledges that LC 9501 will be SB 5570; LC 9502 will be SB 5571, LC 9503 will be SB 5572, and LC 9504 will be SB 5573.
026		VOTE: 3-0
027	Chair Clarno	Hearing no objection, declares the motion CARRIED.
029	Sen. Clarno	Opens a public hearing on SR 2.
<u>SR 2 PUBLIC HEARING</u>		
032	Admin. Taylor	Introduces SR 2 which expresses support and gratitude of Senate to all armed forces personnel for personal sacrifices made in campaign against terrorism. Introduces the –1 amendments (EXHIBIT E).
041	Sen. Peter Courtney	

		Senate District 17. Explains the background behind the drafting of SR 2 to acknowledge the men and women on active duty waging the war against terrorism after the bombing of the World Trade Center on September 11, 2001. Indicates that the –1 amendments were at the request of Sen. Verne Duncan. Points out that Oregon is third in the nation in terms of the number of men and women being deployed in the war on terrorism.
073	Sen. Ferrioli	Notes that it is common in a memorial like this that each senator would want their name added as a sponsor. Says he will remind the members that they have until 5 p.m. to add their name to the bill.
094	Sen. Verne Duncan	Senate District 12. Explains why he asked to have the –1 amendments drafted to add the Army Reserve to SR 2.
121	Sen. Clarno	Wants to make sure no other groups being deployed abroad are being left out.
124	Sen. Duncan	Thinks this amendment covers everyone. After conferring with Ed Hughes, he announces that some <i>individuals</i> may have been called so a reference could be made to thank “all military personnel.”
149	Sen. Gordly	Wonders if line 16 of SR 2, thanking “all of the armed forces personnel”, satisfies that requirement.
155	Chair Clarno	Responds that would satisfy her concern of no one being excluded. Closes the public hearing on SR 2 and opens a work session.
