010	Chair Clarno	VOTE: 3-0 Hearing no objection, declares the motion CARRIED.
012	Sen. Clarno	Announces that the committee will be adopting drafts of legislative concepts as committee bills – not passing legislation out of the committee.
020	Sen. Yih	MOTION: Moves LC's: 4, 8, 9 and 10 BE INTRODUCED as committee bills.
024	Chair Clarno	VOTE: 3-0 Hearing no objection, declares the motion CARRIED.
026	Janet Adkins	Committee Administrator. Indicates that LC 4 will be SCR 19 which adjourns the fifth special session of the Seventy-first Legislative Assembly, LC 8 will be SB 1028 relating to public employee retirement, LC 9 will be SB 1029 relating to judges' retirement, and LC 10 will be SB 1030 relating to retirement of members of the Legislative Assembly (EXHIBITS B – E).
