005	Jim Stembridge	Committee Administrator. Presents HB 2152B along with the –B8 amendment (EXHIBIT A).
019	Joe Landry	Representing the National Electrical Contractors Association (NECA/IBEW). Submits written information (EXHIBIT B) and testifies in support of HB 2152B with the –B8 amendment.
044	Shawn Miller	Representing the Independent Electrical Contractors of Oregon. Testifies in support of HB 2152B and the –B8 amendment.
057	Joe Brewer	Administrator, Building Codes Division (BCD). Testifies in support of HB 2152B and the –B8 amendment.
