008	Chair Beyer	Closes work session and opens public hearing on SB 239.
<b><u>SB 239 – PUBLIC HEARING</u></b>		
033	Keith Putman	Committee Administrator. Explains SB 239.
070	Kelly Taylor	Oregon Department of Transportation. Indicates the need for amending SB 239. Personal property is an issue. Recording liens must apply to title.
140	Emily Sederly	Multi-family Housing Council of Oregon. Testifies that SB 239 as written does not cover needs.
163	Putman	Explains a potential fiscal impact on SB 239.
