Staff subm	nits (EXHIBIT B) as w	vritten testimony from Danny Johnson.
005	Chair Beyer	Asks for clarification on the Johansen case in SB 485.
017	Charlie Cheek	Legislative Councel. States that Section 10 clearly addresses the Johansen case.
033	John Shilts	Administrator, Workers' Compensation Division. Provides update from Management Labor Advisory Committee (MLAC) meeting. Notes that MLAC will receive amendments until 5:00 p.m. tomorrow. States that they will have analysis of current amendments by Friday morning and they will be done after Tuesday's meeting. Submits testimony (EXHIBIT A). Highlights the main issues of the bill in the Matrix. Relates 14 main issues and comparison of the costs and assumptions. States that interim medical benefits were a big issue. Predicts a \$12 million increase. Notes that SAIF Corporation and National Council of Compensation Insurance (NCCI) numbers did not change.
230	Chair Beyer	Closes work session on SB 485 and opens public hearing on SB 439.

250	Keith Putman	Committee Administrator. Explains SB 439.
300	Meg Reinhold	Department of Consumer & Business Services (DCBS). Explains workability of going from 5 to 3 board members in SB 439. Notes that the bill makes all members public, not partisan. Explains that ease of administration is the reason for SB 439 and amendments. Describes the Workers' Compensation Board as an appellate review.

030	Chair Beyer	Explains the rationale of reducing the members of the board in SB 439. Clarifies that this is not a policy setting board but an administrative board.
115	Fred VanNata	Liberty Northwest Company. Notes the needs and duties of the board have changed over the years. Supports the concept of a three member board. States that members should be attorneys representing the "public".
210	Jennifer Webber	Oregon Workers' Compensation Attorneys. Opposes SB 439 (EXHIBIT C). States that decreasing the members of the board would be too limiting.
262	Jim Egan	Oregon Workers' Compensation Attorneys. Testifies that the board is a judicial body. States that SB 439 will increase the appeals workload and that passage of SB 485 will spike the number of cases.
360	Brad Witt	Oregon AFL-CIO, Secretary-Treasurer. Submits written testimony (EXHIBIT D). Testifies in opposition to SB 439. Clarifies how a five member board has decreased workload by 60%. Notes that the system is working and a new statute would cause additional case backlog and that given the complexity of the workers' compensation board, it would be a mistake to decrease the board.

030	Witt	Expresses that the system is far more efficient and cost effective. Notes that work load and fair representation are the two issues.
200	Witt	States the importance that interpretations or case decision is made by parties other than attorneys. Indicates that MLAC has not had an opportunity to consider SB 439. Believes management and labor should make the cases.
