007	Sen. Gary George	Chair. Opens meeting at 3:14 p.m. Opens pubic hearing on SB 47.

010	Patrick Balducci	Committee Administrator. Explains SB 47.
045	Kelly Taylor	ODOT. Gives background on abuses of disabled parking permits. Describes the interim work group that addressed the issue. SB 47 is based on a recommendation of an interim work group (EXHIBIT A).
015	Jacqueline Zimmer	Director, Oregon Association of Area Agencies on Aging and Disabilities (O4AD). Opposes SB 47. Oregon Disabilities Commission also opposes SB 47 (EXHIBIT B,C). Comments that the work group on SB 47 included a former director of Oregon Disabilities Commission. States that O4AD was not aware of the task force during the interim. Agrees that there is an issue of misuse of disabled parking permits. Disagrees that the meters must be plugged. Also disagrees with moving cars during parking time. Discusses issues of disabled persons' inability to use meters and other types of meters. Discusses turnover of parking places in front of businesses. Suggests working on the
200	Jan Campbell	 issue of parking permits for the disabled. O4AD, Oregon Disabilities Commission, Chair, Multnomah County Disabilities Advocacy Advisory Council. Opposes SB 47. Concerned with access to meters and the time limit imposed. Access to meters varies within the state. New meters are too high for someone in a chair. Some people cannot hold coins. Asks committee to look at solutions to help persons with

		disabilities. Other states have succeeded and there is improved technology.
240	Chair George	Asks how other states deal with the parking for disabled people.
244	Sen. Carter	Asks if the work group took into consideration all areas of disabilities.
255	Zimmer	Says their group did not participate in the work group because they were not aware of the work group.
377	Sen. Carter	Says those who cannot handle the meter should not be sanctioned, just those who are cheating.
380	Sen. George	Comments that the committee is interested in trying to find a solution to the problems addressed in SB 47.
384	Zimmer	Discusses affect on income of those who have to pay for services due to disability.

015	Campbell	Says that some disabled persons have to pay costs due to lack of access.
024	Patrick Balducci	Discusses the lack of compromising on both sides of the issue. Notes that the problem is of abuse. Approximately ten percent of the vehicles parking in Portland use placards. Suggests bar coding the placards so that identification can easily and quickly be obtained and issuing special permits to severely disabled.
075	Edward Necker	Opposes SB 47. Agrees with Jacqueline and Jan.
109	Catherine Jenness	Lane County. Agrees with Jacqueline and Jan. Discusses the varied physical disabilities are and how they affect a person's dexterity and physical ability. Opposes SB 47.
173	Kelly Taylor	ODOT. Explains how the permits are processed.
250	Chair George	Suggests adding a dash number to identify different issues of parking passes by one individual.
233	Necker	Discusses the usefulness of data base information.
243	Balducci	Notes a need for a process so that meter readers can trace placards. Access would be made easier by keeping data base information more accessible to meter readers.
280	Rick Berger	Member of Disabilities Services Advisory Council for Multnomah County. Opposes SB 47. Agrees with the attempt to increase penalties for placard abusers and abuse of disabled parking spaces. Says disabled people are being punished for the abuse of a few. Discusses the economic hardship of some disabled people. Explains that the process that disabled persons have to go through to get services often involves waiting time.

005	Theresa Flowers	Elderly in Action. Describes her personal experience using a handicapped van and scooter. Describes the effects on the handicapped of inclement weather, low income, and time consuming efforts disabled people must undergo to live in the everyday world. Suggests citizens' arrests for abusers of parking permits.
061	Patrick Rogers	Paralyzed Veterans of America. Worked with the group on SB 47. Supports most of the bill. Looking for ideas to stop abuse of disabled placards. Says that disabled people who travel need consistent rules about parking. Says abuse is the issue (EXHIBIT E).
112	Roger Turk	Portland. Describes his personal experience as a muscular

		dystrophy patient trying to get around. Frequently uses the disabled parking spaces in Portland. Says those spaces are very important to people. Convenience is important for handicapped people.
156	Turk	Continues discussion on disabled parking permits. Says the
175	Rob DeGraff	parking program has improved over the years. Association for Portland Progress. Supports the effort that has gone into SB 47. Gives background on retailers in downtown Portland. Emphasizes importance of street meters to downtown Portland.
250	Susan Schneider	City of Portland, Government Relations. Supports interim committee's recommendations on SB 47. City of Portland is open to any ongoing work addressing parking abuse.
263	Sen. Carter	Asks if there were disabled representatives on the work group.
270	Ann Larkin	City of Portland, Parking Enforcement. Responds that Patrick Rogers and Roger Robinson and some other disabled volunteers working for the State Police were on the work group.
275	Sen. Carter	Asks if meters were discussed at the work group.
277	Larkin	Says the group did not come to a conclusion on that issue. However, more discussion has centered on permit programs or identifying vehicles that would have adaptation devices that enforcement could identify.
290	Sen. Carter	Asks if the of work group could continue working toward a solution.
295	Larkin	Answers that some members of the group would likely be willing to meet again.
309	Sen. Messerle	Says he is worried about this bill. Asks how much revenue would be gained from the meters.
318	Larkin	Responds that revenue was not the reason for the work group, but that parking abuse was the focus.
323	Andrea Fogue	League of Oregon Cities. Supports interim committee's recommendations. Says this is not a Portland solution but needs to be solved statewide.
343	Sen. Metsger	Reiterates that there is agreement among the interested parties that there is abuse and also they agree on penalties. However, the incentives are not great enough to stop abuse. Asks if tightening access to placards, increasing fines and tighter enforcement should be part of the solution.
