009 Chair Ferrioli Called meeting to order at 8:05 a.m. The Chair introduced himself and outlined what would be

		covered in today's meeting. The Chair also outlined what the role of the Senate Revenue Committee will be in the 2001 Legislative Session. Mr. Paul Warner was then introduced.
019	Paul Warner	Welcomed the members of the Senate Revenue Committee back to the capitol. Spoke about similarities between Senate Revenue and the Ways and Means Committee process, and that the same Legislative Revenue Office staff also handles the House Revenue Committee. That creates some continuity in bill and measure analysis. Mr. Warner then introduced all the LRO staff.
053	Chair Ferrioli	Stated that he would be making appointments with each member of the Senate Revenue Committee to discuss their committee objectives and expectations with the hope of making this a much more "activist committee" than has been the case in the past two sessions. He acknowledged Vice Chair Beyer's long- standing work with revenue committees.
063	Chair Ferrioli	Mentioned one other "housekeeping" matter. Because three members have to commute from Eugene/Springfield, Vice Chair Beyer asked if Senate Revenue could begin at 8:30 a.m. instead of 8:00 a.m. for the first two months or so. Hearing no objection, Chair Ferrioli stated that beginning January 11, 2001, Senate Revenue Committee would meet at 8:30 a.m. until further notice.
085	Warner	Introduced the Legislative Revenue Office economists and outlined their areas of expertise. (Exhibit 2 — Staff Specialties.)
121	Chair Ferrioli	Stated there were some orders of business to be attended to. First was Adoption of Committee Rules. Exhibit 1 — Proposed Sample Committee Rules. Motion to adopt proposed rules. Hearing no objection, proposed rules

were adopted.

138	Chair Ferrioli	Discussed Planning Calendar for Committee Members & Staff. Stated this was a valuable tool for members to keep up with committee work. Exhibit 3.
142	Warner	Discussed the Week at a Glance planning schedule. Also referred to Committee Member's Planning Calendars and Bill Files. Exhibit 4.
155	Warner	Oregon Public Finance: Basic Facts. In past years it was called the "Basic Tax packet". Said it should serve as a good reference document for committee members. Exhibit 5.
195	Chair Ferrioli	Stated he had reviewed an advance copy of a document the other committee members recently received and that there was information that would direct them to options as a legislative body. Spoke about what issues may possibly be brought before the Senate Revenue Committee during the 2001 session.
235	Warner	Personal Income Tax — General Provisions. Discussed ORS 316.003 in detail, which describes goals of the tax system. Exhibit 6.
295	Warner	Began discussion of Revenue Committee Background for 2001 — Legislative Session. Discussed each slide in detail. Discussed Slide 2 — Tax System Goals. Exhibit 7.
390	Warner	Began discussion of Slide 3 — Oregon's Economic Performance in the 1990's. Stated that the 1990's were good for Oregon overall, but that 1998 to 1999 was not good. Job growth is well below 1%. Oregon's economy is one of the poorer performing in the country compared with the rest of the states.
