- 077 Rep Diane Rosenbaum Testified in support HB 2716-A. Stated the bill is one of the most significant opportunities presented this session to provide meaningful help to hard-working Oregonians struggling to escape poverty and trying to feed their families. This bill benefits not only employees with a tax credit but benefits employers as well. For people making minimum wage or barely above that, it is a daily struggle to provide bare necessities for their families and to pay for child care.
- 117 Chair Ferrioli Commented that there will be a public hearing only on this bill today because of its projected fiscal impact.

257 Chair Ferrioli Reminded members that this bill was heard on April 24, 2001. At that time the motion made by Sen. George to move the original bill to the Senate Floor was interrupted by adjournment of the meeting. In order to complete the unfinished business, placed Sen. George's motion before the Senate Revenue Committee.

262	Sen. George	MOTION:
		MOVES TO WITHDRAW PREVIOUS MOTION TO MOVE SB 260 AS ORIGINALLY DRAFTED.
266	Sen. George	Added that during the time since his original motion, substantial progress has been made among the interested parties who have agreed to additional amendments, thus causing the withdrawal of the original motion.
271	Chair Ferrioli	ORDER:
		HEARING NO OBJECTION, THE CHAIR SO ORDERED.
280	Chair Ferrioli	Recessed meeting from 9:23 a.m. to 9:30 a.m.
283	Chair Ferrioli	Stated that it is the Chair's intention to present the (-7) amend-ments for discussion.
286	Steve Meyer	Discussed the (-7) amendments to SB 260 (Exhibit 10) in detail.
		Explained that Sections 1 through 8 deal with the phase-in period. Sections 9 and 10 address permanent equalization after the phase-in. Sections 11 to 18 are concerned with administrative and technical changes. Sections 19 to 23 deal with the resolution process at 90%. Sections 24 to 26 address competitive bidding language. Section 27 establishes an interim task force to study ESD services, deficiencies, and availability of those services. Sections 28 to 33 after full equalization phase- in repeals the Grant and Wallowa local equalization process with their component districts.
311	Meyer	Stated this is a five-year phase-in plan. Went into minute detail of each section of the (-7)

amendments ..

013	Meyer	Continued minute detail of each section of the (-7) amendments. Questions and answers followed.
148	Sen. Castillo	Asked if Ozzie Rose could be allowed to testify on what he thinks about the (-7) amendments.
151	Chair Ferrioli	Stated the Chair's intention was not to listen to additional testimony, amendments, runs, or debate. Senate Revenue has been hearing this bill since January. The Chair intends to move the (-7) amendments into the bill. The Chair believes the (-7)s incorporate most of the work done by the ESD task force and offers the best balance for rural and urban ESDs at this time. Feels this should be presented before a different committee and then brought to a conference committee for final agreement. Concerned that if another amendment and another set of runs is presented today, affected ESDs will either be happy or unhappy, and cause yet another set of amendments and runs to be generated. It would never end. Believes the (-7)s are the best compromise.
210	Sen. Castillo	Stated this is a significant piece of legislation that will have a tremendous effect on children in Oregon. It was her understanding that Ozzie Rose had been directed to produce a proposal everyone could agree on. Further declared Mr. Rose has done that, but is frustrated that the Chair will not allow Mr. Rose to present it to the committee. Because Mr. Rose has a proposal representing all ESDs with agreement on a final proposal, feels he should at least be able to make a comment about why the (-7)s do not meet the test of full agreement from all the ESDs.

224	4 Chair Ferrioli	Stated he appreciated Sen. Castillo's comment, but found it ironic. Sen. George's motion on April 24 was to move SB 260 as drafted (with no amendments) to the floor with do pass recommendation. Had that occurred, it is likely it would have passed and moved to the House chamber as drafted. At any time from January through May 100% closure could have been reached, but that has not happened. The Chair has held onto this bill to try to get it to closure far longer than most other Chairs would have done. At this point has lost confidence in the ability of people to deliver what they say they can deliver. It's time to move this bill.
		Added that the Chair has observed disheartening self-interest displayed in this process, (i.e. people motivated to protect their own jurisdictions and constituents) and understands that action, but in this case has seen it used as a club against moving SB 260. Is not very pleased. Has lost confidence in the ability of people to come riding over the hill waiving the ultimate solution to the problem at the 11 th hour.
27:	5 Vice Chair L. Beyer	Stated he understands there is a proposal having the support of all but one of the ESDs. If SB 260 moves to the House side and gathers support there, asked if it was the Chair's intent to concur.
282	2 Chair Ferrioli	Agreed it would be the Chair's intent to be sure there was equity and fairness in how the dollars would be distributed. Pointed out, however, there were not huge differences between the (- 7) amendments discussed today and other amendments purported to exist. Still intends to move SB 260 out today because it is a major step forward to achieving equalization.
313	3 Sen. Corcoran	Commented regarding his feelings about how the process has transpired regarding SB 260 and the (-7) amendments.

368	Sen. Minnis	Asked for explanation of what the corrections in fact correct.
370	Meyer	Explained the primary change is regarding balancing the total amount the formula allocates to the ESDs to the available revenue. Since that may or may not be the case because of the percentages in the bill, this correction refers to a final adjustment to both ESD state school fund and local revenue such that the amount allocated equals what is available.
