EXECUTIVE APPOINTMENTS

PORT OF PORTLAND, BOARD OF COMMISSIONERS OF - BOB EATON - WORK SESSION

008	Chair Harper	Comments that during the hearing on the appointment of Eaton, several issues were raised. One was the conflict of interest

between the Port of Portland and the Port of Astoria. Another was a commitment to channel deepening, when done appropriately. Also a concern was a general lack of business sense. Asks Bill Wyatt to comment on Eaton's potential conflict of interest and deepening of the Columbia River.

015 Bill Wyatt Chief of Staff to Governor John Kitzhaber, M.D. Submits a copy of a letter from Eaton to himself stating that Eaton agrees to resign from the Port of Astoria pending confirmation of appointment to Board of Commissioners of the Port of Portland **(EXHIBIT A)**.

Wyatt States that Eaton's resignation is pending because he holds an elected position with the Port of Astoria and the Port of Astoria would be in a bind, but he fully intends to resign as soon as he is confirmed for the Port of Portland.

Wyatt Regarding the channel deepening project, reiterates testimony by Governor Kitzhaber to the committee that he supports this project and believes it is very important for the future of the Port and the region, that the project is not going to happen unless it comports with all the relevant environmental challenges that confront it. His view is that somebody in Eaton's position reflecting the needs and the interests of the lower Columbia River is going to make that more likely rather than less likely. In any event, he would not have appointed Eaton, having had a number of discussions with him, had he thought in any way that Eaton was going to be an obstacle to the channel deepening project. Thinks Sen. Beyer asked Eaton directly for his approach and Eaton said he would support the project. States that he has confirmed that with Eaton.

Explains that he added the language in line 6 of the -A6 amendments, "As a condition of the local government providing direct tax abatement or subsidies..." to make it clear the local government is providing the local tax abatement or subsidy. Adds that he also added a new Section 2 to make it clear that the measure applies prospectively and would not apply to previous agreements entered into by local governments.

HB 3350-A - PUBLIC HEARING

398 Craig Allen

Advises members they have the HB 3350-A11 amendments **(EXHIBIT I)**.

404 Jack Roberts

Commissioner, Bureau of Labor and Industries (BOLI). Explains that HB 3350-A is straightforward. It operates prospectively to exempt from the operation of the Prevailing Wage Rate Laws projects which no funds of a public agency directly or indirectly are used and gives authority to the Labor Commissioner to write rules for implementation. Explains that the -A11 amendments are an attempt to deal with a problem. Explains that a couple of projects are ongoing that are being performed by private non-profits. They embarked on the projects believing the Oregon Prevailing Wage Rate Law would not apply and are now facing a situation where they believe those costs would be incurred. The -A11 amendments attempt to provide a safe haven for them that will protect them from a general enforcement action by (BOLI), but will still allow individual workers to file claims for amounts they should have received under the Prevailing Wage Law.

433 Roberts

Explains that lines 4 through 12 are clarifications that funds of public agencies do not include grants to a private non-profit that are not issued for the purpose of construction. It is to protect non-profits that are getting grants all the time for operation. The relevant part is on line 15 of page 1 of the -A11 amendments. The language provides that BOLI may not initiate or continue a general enforcement action to collect prevailing wage rates on projects that would have been exempt had this bill been in effect. It does permit BOLI to accept wage claims that may be filed and that BOLI would pursue.

Adds that they believe this is a reasonable compromise. They have worked with labor representatives and others to craft the compromise.

Comments that the Salem Carousel Project had a lot of volunteer hours and this bill will help.

Comments that the City of Gresham also has a sports park project they are trying to do similarly to the Salem Carousel Project.

Director, Department of Community Services, City of Salem.

Submits letter from Salem Mayor Swaim **(EXHIBIT J)**. States the amendments deal with their initial concern but there is a desire to have more flexibility. Asks if there is opportunity to allow some public assistance in a small amount.

Explains that even \$1 would trigger the prevailing wage. Also if a group were to put in a playground as part of a park

development, it would trigger the prevailing wage.

Oregon Building Trades Council. Comments he has worked with BOLI on the amendments and talked to some of the non-profits and feels this gives them a bright-line standard to maintain the law. Explains that in 15 years he has never run across this incident and then had three or four cases in a two-month period. States it was always their understanding that the Prevailing Wage Law was applicable when public funds were being utilized. Adds that no single group does more donation work than the Building Trades Council. They do multiple charitable contributions of construction every day throughout the state. Adds that they do not want to see the area's standard wages and benefits diluted.

Responds they would because they are trying to have some kind of standard that BOLI can look at to see if the activities fall under the Act.

willing to work with her and they have found a combination of medicines that help her be able to participate in the political process.

States that a commission is needed to develop a criterion so that people are not going to their doctor and being told they cannot prescribe medicines because it would be addictive.

Their focus is pain conditions. States that general physicians are asking for education because they feel frustrated taking care of people who do not get better but are taking increasing amounts of narcotics.

Scott Gallant

Oregon Medical Association (OMA). Comments that the OMA opposes SB 885 as currently drafted and the SB 885-4 amendments. Comments on previous attempts to amend the statutes and concerns of physicians that they would be subject to discipline by the Board of Medical Examiners (BME). States the issue was resolved by working with the BME and the issue has continued on chronic pain management and end-of-life care. States the committee has received a letter from the BME opposing the legislation (**EXHIBIT R**). Reviews letter. Comments on training programs and courses available to physicians.
