012	Keith Putman	Administrator. Explains the purpose of this meeting is to adopt the rules for House Business and Consumer Affairs Committee for the 1999 Legislative Session. Points out that the only significant change to the rules is a 36 hour lead time for posting an agenda. Explains this differs from last session's 24-hour rule.
020	Rep. Gardner	MOTION: Moves to ADOPT the proposed Committee Rules dated 1/15/99 (EXHIBIT A).
		VOTE: 6-0 EXCUSED: 1 ñ Rep. Thompson
022	Chair Beyer	Hearing no objection, declares the motion CARRIED.

028	Chair Beyer	Explains some of the upcoming bills that have been scheduled for a Public Hearing and Possible Work Session.
035	Putman	Presents a brief overview of next meeting's agenda. Explains it is an Informational Meeting at which the committee will hear testimony from Oregon State Department of Consumer and Business Services.
042	Putman	Explains that the committee will be hearing bills dealing with changes in the Occupational Safety and Health Division (OSHA) and possible related issues.
073	Chair Beyer	Requests an introduction from each member. Introductions proceed with the following: Representatives Winters, and Atkinson, Vice-Chair Knopp, Administrator Putman, Chair Beyer, Vice-Chair Gardner, and Representatives Thompson, and Morrisette. Each gives a brief statement about themselves, their district, and geographic area which they represent.
