042	Santos	Explains the problem is two fold: mandating curriculum and a particular program.
047	Rep. Winters	Asks if it makes a difference if the program is funded by an outside source.
049	Santos	Responds that alleviates only one concern.

115	Jim Green	Legislative Representative, Oregon School Board Association (OSBA.) Testifies against SB 887A. States bill contains a mandate for only public schools; leaves out private schools and home schoolers.
120	Rep. Wilson	Responds this represents an extra measure of safety for public schools.
129	Green	Comments it is the parentsí responsibility to teach firearm safety, not the schools which have responsibility for academic issues.
133	Rep. Wilson	Comments that schools already take on parental roles; feeding students, etc.
161	Green	Responds mandating programs like this takes time away from academic programs.

186	Rep. Jenson	Asks why would not public school administrators advocate for this kind of a safety program.
190	Green	Relates discussion with superintendents in Marion County.
205	Rep. Winters	Comments the issue is whether the school wants to do it or not, notwithstanding any potential expenses.
212	Green	Discusses issue of mandating additional curricula in a full school day.
215	Rep. Winters	Asks if this also applies to topics of health taught in the school.
220	Green	Explains the number of items added to the school day which are not strictly academic.
234	Rep. Starr	Asks if there have been any "unmandates" from OSBA.
236	Green	Comments on his first effort at eliminating a mandate.
245	Rep. Starr	Refers to charter schools and its preference for no mandates.
254	Green	Comments on an OSBA charter school bill in a previous legislature.
267	Rep. Hopson	Comments on the length of the school day and how long students/ teachers are in school.
275	Rep. Close	Notes that the "Eddie Eagle" program is taught by volunteers. Asks if firearm safety is a life/death issue.
280	Green	Agrees, but thinks good parents should do the instruction.
285	Rep. Close	Asks for explanation of a mandate that is life/death and one that is not.
295	Green	Explains time constraints on the school day.
299	Rep. Jenson	Asks if OSBA is proposing that schools eliminate instruction on safety issues.
315	Green	OSBA does not advocate that; asks committee to recognize the demands on the public schools.
325	Chair Sunseri	Recesses public hearing on SB 887A. Opens public hearing on SB 751A.

334	Sen. Avel Gordly	District 10. Testifies in favor of SB 751A which allows the adoption of a policy to require students to wear school uniforms.
412	Rep. Beck	Expresses concerns with the issue of costs; how to determine.
433	Sen. Gordly	Recommends consulting schools that are currently using uniforms and ascertaining how they have dealt with costs.

015	Rep. Beck	Asks if schools can implement a dress code now, why is this bill needed.

032	Sen. Gordly	Responds "common sense" will show that uniforms cost less than the average school wear.
