005	Chair Kruse	Opens the meeting at 1:05 PM.
010		Explains that the committee will not be adopting rules today. Subcommittees for Human Resources have not been announced by the Speaker. States that the committee will adopt rules after Speaker Snodgrass has made her announcements.
017	Chair Kruse	Introduces Committee Staff.
023	Chair Kruse	Explains that he intends to meet with each committee member to find out what members think the goals of the committee should be. States that the committee is going to have a large agenda this session and a limited time frame to meet the work load.
032	Chair Kruse	Describes personal rules of the Chair: <ul style="list-style-type: none">• Expects Committee to start on time• Members will not interrupt witnesses during testimony, please write down questions and get the attention of the Chair• Everyone should behave in a professional manner that honors the offices held by the representatives.
060	Chair Kruse	Explains that the first few meetings for the committee will be informational meetings regarding state agencies and local programs. He has been involved in the juvenile justice training meetings that have been taking place all week. Encourages committee members to attend the informational meeting in room 343 on effective early childhood interventions upon adjournment of this meeting.
065	Rep Morrisette	Asks about the two sub-committees referred to earlier by Chair Kruse.
075	Chair Kruse	States that he would prefer to wait for the Speaker's announcement before discussing Human Resource sub-committees. Explains that all members of the standing committee will be on a sub-committee.
072	Rep. Morrisette	Asks if the sub-committees will meet during the regular committee time.
075	Chair Kruse	Underlines that he does not want any sub-committee to take time away from the standing committee. Hopes that sub-committees will be given their own time slots. <ul style="list-style-type: none">• This committee has a scheduled running length of 2 hrs.• The committee may need to schedule additional meetings, possibly in the late afternoons or evenings, if the workload requires it and permission is granted.
