002	Chair Knopp	Calls the meeting to order at 3:45 P.M. and opens a public hearing on HB 2702.

HB 2702 PUBLIC HEARING

004	Janet Carlson	Summarizes the bill.
009	Rep. Kruse	Explains that HB 2702 recommends a task force that looks into the systems and structures of state licensing boards. Reports that current legislation has been brought forward to allow 22 new boards semi-independent status. States that it is time to review the intelligence of these decisions. Explains that inspections of some care facilities are being duplicated and are inconsistent. Discusses problems regarding information exchange among boards and institutions. Maintains that serving and protecting Oregon citizens is the primary responsibility of licensing boards. Intends to move the bill in the full committee of Human Resources. Asks for input from the public and various board members.
072	Chair Knopp	Enters into the record testimony received from the Oregon Dental Association (EXHIBIT A), Oregon Nurses Association (EXHIBIT B), and Oregon Board of Radiologic Technology (EXHIBIT C).
085	Chair Kruse	Maintains that he is open to comments and suggestions regarding improvements to HB 2702.
088	Chair Knopp	Closes the public hearing on HB 2702 and opens a work session on HB 2702.
