122	Vice-Chair Devlin	Asks if there has been an analysis to determine the overall cost of securitization of the settlement funds.
145	Gest	States that securitization is more productive for the state is goals. Discusses the idea of using securitized tobacco payments for the proposed budget stabilization fund and educational programs.
179	Vice-Chair Starr	States that it is important to remember that smoking prevention, education and cessation programs need to be funded, as well as affordable housing and senior transportation.
