264	Bill Sizemore	Oregon Taxpayers United. Supports SB 867A. Discusses the history of confusing initiative questions, the positive response to legislation designed to simplify initiative statements and the effects of vote by mail on the word requirement. Explains that SB 867A allows for simpler wording on initiative summaries. Notes that the ñA4 amendments represent a compromise with the Attorney Generalis office (EXHIBIT G).
319	Rep. Williams	Refers to EXHIBIT H . Comments on the confusing wording in past initiative

		summaries due to the 15-word requirement.
336	Rep. Edwards	Asks if the current 15-word requirement includes conjunctions and articles.
340	Sizemore	Replies yes. Adds that the 25-word requirement will allow the use of articles and conjunctions, translating into more readable summaries.
359	Rep. Edwards	Asks for comments on page 2 of the bill.
363	Sizemore	Replies that the expansion of the summary requirement to 125 words follows the same reasoning: to allow more flexibility and thoroughness in the explanations. Notes that local ballot measures have 175-word requirements. Describes what will be included in the vote-by-mail packets.
401	Rep. Edwards	Cites page 2, line 7. Asks about the subjectivity of the reference to normal written or conversational speech.
410	Sizemore	Replies that this phrase defines the standard for simplicity.
424	Chair Simmons	Notes that the ñA4 amendments replace all of section one.

012	Rep. Mannix	Notes the constrictive bureaucratic regulations surrounding campaign volunteers and employees. Explains the ñA5 amendments, which add a new section to the bill dealing with the status of persons who provide election services for remuneration. Indicates that the amendments are designed for a more informal campaign structure. Reviews the specific requirements on campaign-related "independent contractors" (EXHIBIT I).
066	Sizemore	Supports the ñA5 amendments if there are enough votes on committee. Comments that the proposed changes will apply to independent paid petitioners.
092	Rep. Gardner	Opposes independent contractors, noting the lack of insurance coverage and other benefits.
099	Rep. Devlin	Asks if Sizemore employs his own petitioners or contracts with a national firm.
108	Sizemore	Replies that they contract with Oregon petition companies for approximately 80% of their work. Discusses the independent petitioner process, the problems with classifying them as employees, and their actual status as independent contractors.
