005 Chair Strobeck Explained the bill, as it passed out of the House, had the provision for an appeal to be based on the real market value only. The Senate added in the assessed value. The House felt the assessed value was irrelevant since under Measure 50 the assessed value is based on the real market value. Requested Ms. Martin-Mahar discuss the third alternative, in the form of the (-A2) amendment. (Exhibit 1)

012	Lizbeth Martin- Mahar	Described the (-A2) amendment, which stipulates that once a taxpayer meets the necessary conditions, the taxpayer can appeal either the real market value or the maximum assessed value to the property tax appeals board. Lines 5-9 of the amendment will clarify issues discussed in the Senate as to what can be appealed once the gross error criteria is met. The critical issue is to make the statutes clear that both the maximum assessed value and the real market value can be appealed. (Exhibit 1)
